

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES  
(STRATFORD ROAD (PART), WOLVERTON)  
(40 MPH SPEED RESTRICTION) ORDER 2014**

**WHEREAS** the Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under sections 84(1), (2) and (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order: -

1. This Order may be cited as the Council of the Borough of Milton Keynes (Stratford Road (Part), Wolverton) (40 MPH Speed Restriction) Order 2014, and shall come into force on 24<sup>th</sup> January 2014.
2. No person shall drive any class of vehicle at a speed exceeding 40 miles per hour on the length of road specified in Schedule 1 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. The plan annexed to this Order identifies the length of road subject to this Order, provided that where there is any inconsistency between the plan and the Schedule it is the wording

of the Schedule which shall prevail.

5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Schedule 2 hereto are hereby revoked or varied to the extent stated in that Schedule.

### **SCHEDULE 1**

#### **40 MPH SPEED RESTRICTION**

##### **STRATFORD ROAD, WOLVERTON**

SL1 – From a point 33 metres west of a point in line with the centre line of its junction with Trinity Road, Wolverton for a distance of 310 metres in a westerly direction to its junction with Great Monk Street and Old Wolverton Road.

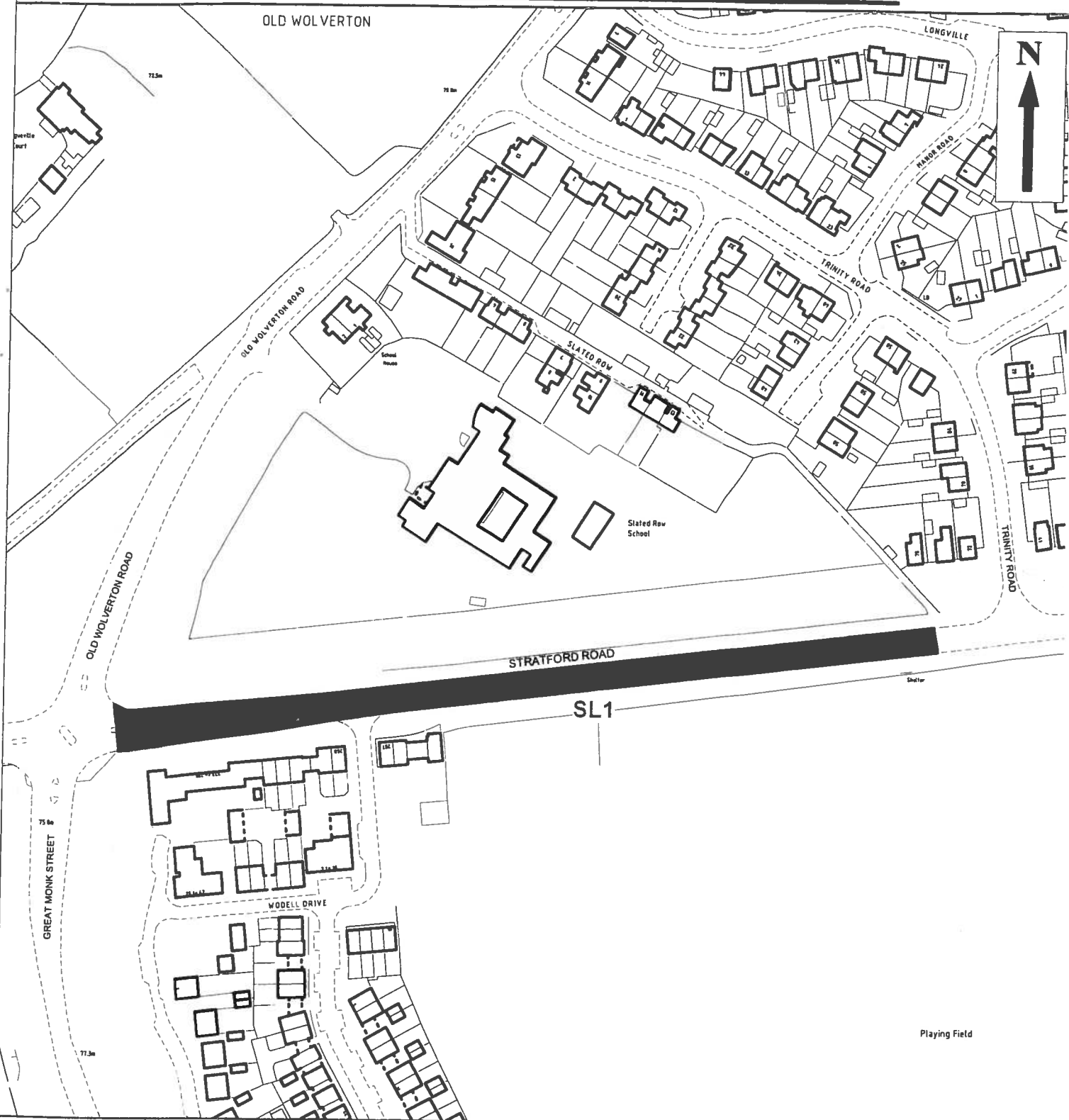

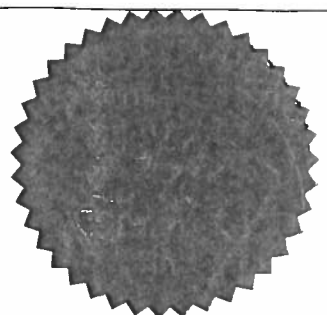


