



**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES

ORDER 2005) VARIATION ORDER 2014**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 1(1), 2(1) and (2), 4(2), 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

**PART 1  
IMPLEMENTATION AND CITATION**

1. This Order shall come into operation on the 15<sup>th</sup> day of May 2014 and may be cited as "The Council of the Borough of Milton Keynes (The Council of The Borough of Milton Keynes (Various Roads, Central Bletchley and Fenny Stratford) (Prohibition and Restriction of Waiting and Stopping) Order 2005) Variation Order 2014".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plans annexed to this Order identify the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Schedules it is the wording of the Schedules which shall prevail.
4. The plans annexed to this Order are hereby annexed to The Council of The Borough of Milton Keynes (Various Roads, Central Bletchley and Fenny Stratford) (Prohibition and Restriction of Waiting and Stopping) Order 2005 and form part of that Order.

**PART 2**  
**VARIATIONS**

5. The Council of the Borough of Milton Keynes (Various Roads, Central Bletchley and Fenny Stratford) (Prohibition and Restriction of Waiting and Stopping) Order 2005 ("The Principal Order") is varied as provided by the following provisions of this Order:-
6. Item NW29 in Schedule 1 of the Principal Order is revoked and replaced as follows:-  
BROOKLANDS ROAD, BLETCHLEY – WEST SIDE  
NW29 From a point in line with the southern kerbline of Findlay Way for a distance of 25 metres in a southerly direction.
7. The following item NW50 is inserted into Schedule 1 of the Principal Order as follows:-  
BROOKLANDS ROAD, BLETCHLEY – WEST SIDE  
NW50 From a point 60 metres south of its junction with Findlay Way for a distance of 18 metres in a southerly direction.
