

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE
BOROUGH OF MILTON KEYNES (VARIOUS ROADS WITHIN MILTON KEYNES AND
SURROUNDING AREAS) (PROHIBITION OF STOPPING OUTSIDE SCHOOLS)
ORDER 2008) VARIATION ORDER 2014**

The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 1(1), 2(1) to (3), and 4(1) & (2) of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on 24 April 2014 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads within Milton Keynes and Surrounding Areas) (Prohibition of Stopping Outside Schools) Order 2008) Variation Order 2104".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan(s) annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plan(s) and the Articles it is the wording of the Articles which shall prevail.
4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereto are hereby revoked to the extent stated in that Part.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Various Roads within Milton Keynes and Surrounding Areas) (Prohibition of Stopping Outside Schools) Order 2008" ("The Principal Order") is varied as provided by the following provisions of this Order:-
 - 1) The following definitions are removed from Part 1 of the Principal Order:-
"disabled persons' badge" and "disabled persons"
 - 2) The following articles are removed from Part 2 of the Principal Order:-
7, 8 and 9
 - 3) Part 4 and article 17 are removed from the Principal Order.
 - 4) The following item NS41 in Schedule 1 of the Principal Order is varied to the extent stated below:-

FAIRFAX, BRADVILLE
WEST SIDE
NS41 From the entrance to Stanton School, continuing for a distance of
27.5 metres in a southerly direction

- 5) The following item NS55 in Schedule 1 of the Principal Order is varied to the extent stated below:-

**HOLBORN CRESCENT, TATTENHOE
SOUTH-EAST SIDE**

NS55 From a point 23 metres north-east of its junction with the north-eastern entrance to Giles Brook Primary School, continuing for a distance of 43.5 metres in a south-westerly direction.

- 6) The following items are inserted into Schedule 1 of the Principal Order:-

**CUSHING DRIVE, OXLEY PARK
EAST SIDE**

NS132 From a point 11.5 metres north-east of the north-western boundary wall of number 214 Cushing Drive, continuing for a distance of 25.5 metres in a north-easterly direction.

**CUSHING DRIVE AND REDGRAVE DRIVE, OXLEY PARK
SOUTH SIDE, SOUTH-WEST AND SOUTH-EAST SIDE**

NS133 From a point 10.5 metres east of the south-western boundary wall of number 2 Cushing Drive, continuing for a distance of 25.5 metres in a north-easterly then south-easterly then north-easterly direction

6. The following school is inserted into Schedule 2 of the Principal Order:-

Oxley Park Academy, Oxley Park

7. The following Order is HEREBY REVOKED to the extent stated below:-

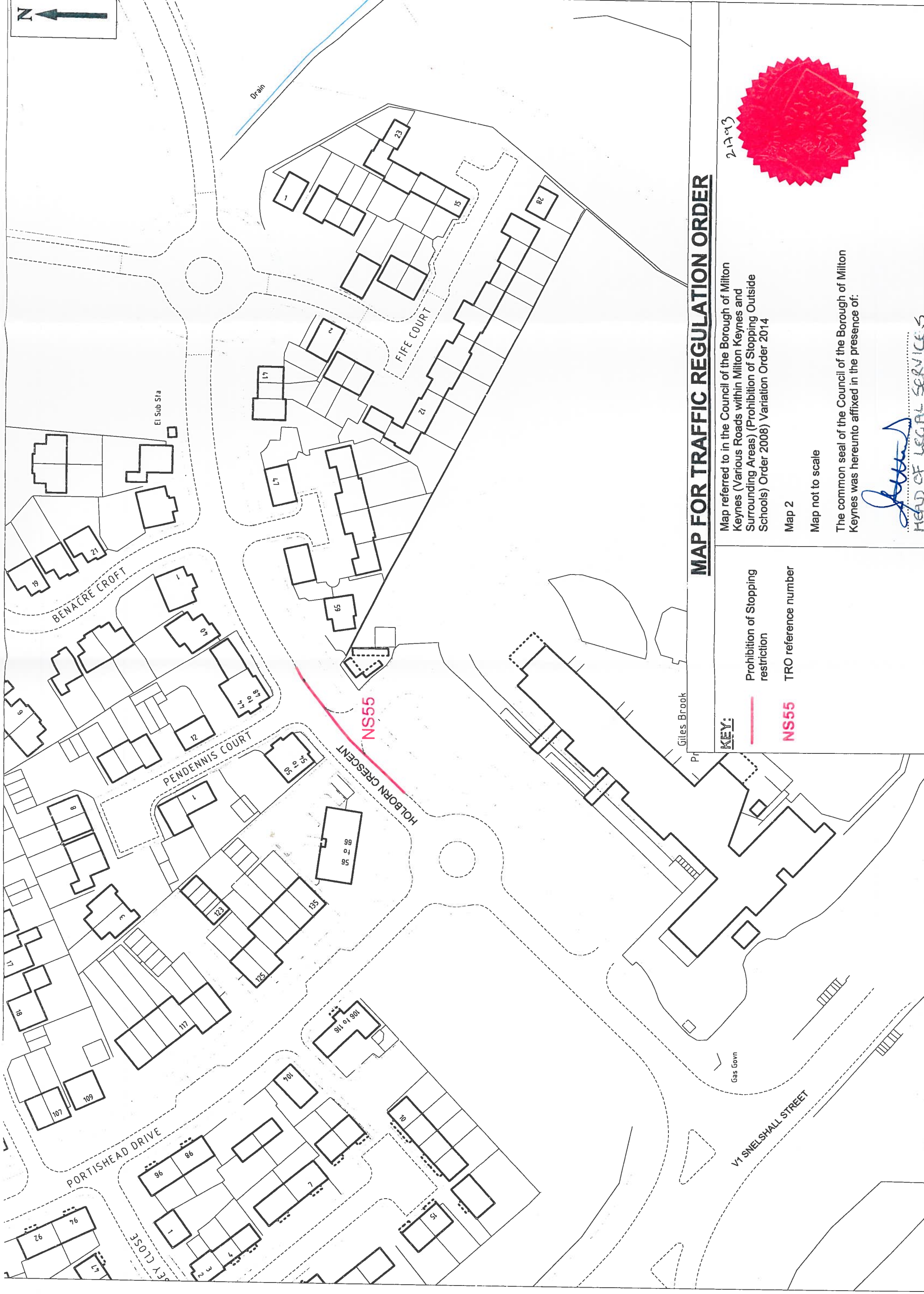

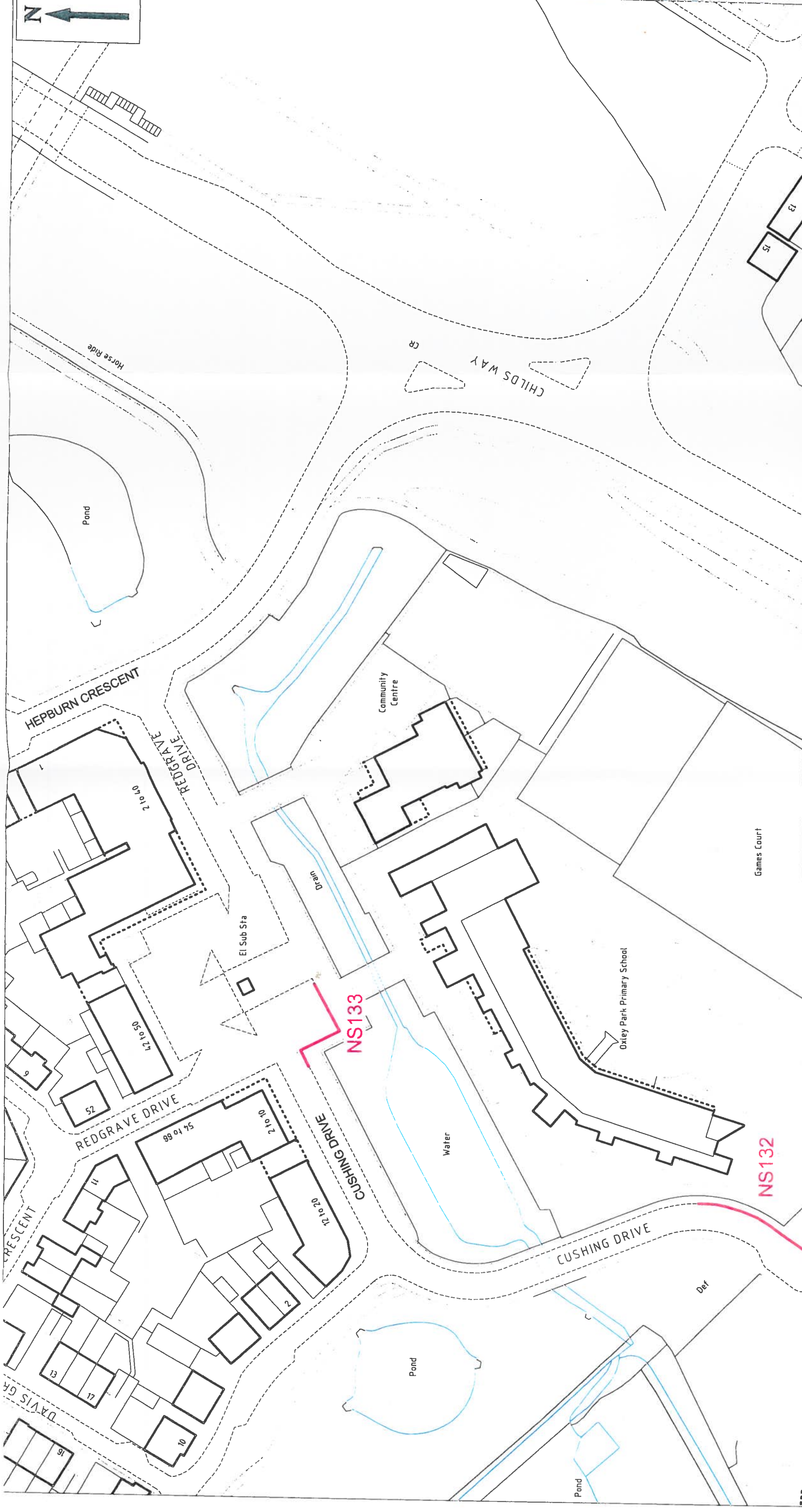
