

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF  
THE BOROUGH OF MILTON KEYNES) (VARIOUS ROADS, STONY STRATFORD)  
(CONSOLIDATION OF PARKING AND WAITING RESTRICTIONS) ORDER 2002)  
VARIATION ORDER 2014**

The Council of the Borough of Milton Keynes ("the Council") in exercise of the powers of the said Council under Sections 1(1), 2(1) to (3), and 4(1) & (2) of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 hereby makes the following Order:-

**PART 1**

**IMPLEMENTATION AND CITATION**

1. This Order shall come into operation on 24 April 2014 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads, Stony Stratford) (Consolidation of Parking and Waiting Restrictions) Order 2002) Variation Order 2014".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan(s) annexed to this Order identify the lengths of roads subject to this Order, provided that where there is any inconsistency between the plan(s) and the Articles it is the wording of the Articles which shall prevail.
4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Part 3 hereto are hereby revoked to the extent stated in that Part.

**PART 2**

**VARIATIONS**

5. "The Council of the Borough of Milton Keynes (Various Roads, Stony Stratford) (Consolidation of Parking and Waiting Restrictions) Order 2002" (The Principal Order) is varied as provided by the following provisions of this Order:-
  - 1) The following item NW60 in Schedule 1 of the Principal Order is varied to the extent stated below:-

OUESBANK WAY, STONY STRATFORD  
NORTH-WEST SIDE  
NW60(i) From a point 21 metres south of its junction with Calverton Road, continuing for a distance of 17 metres in a southerly and south-westerly direction.

OUESBANK WAY, STONY STRATFORD  
SOUTH-EAST SIDE  
NW60(ii) From its junction with Calverton Road, continuing for a distance of 38 metres in a southerly and south-westerly direction.

- 2) The following item NW65 in Schedule 1 of the Principal Order is varied to the extent stated below:-

RUSSELL STREET, STONY STRATFORD  
SOUTH-WEST SIDE

NW65 From its junction with New Street, for a distance of 39 metres in a south-easterly direction.

- 3) The following item NW90 in Schedule 1 of the Principal Order is varied to the extent stated below:-

WOLVERTON ROAD, STONY STRATFORD  
NORTH-WEST SIDE

NW90 From a point in line with the common boundary line of numbers 43 and 45 Wolverton Road, continuing for a distance of 25 metres in a south-easterly direction.

- 4) The following item NW124 in Schedule 1 of the Principal Order is varied to the extent stated below:-

YORK ROAD, STONY STRATFORD  
NORTH-WEST SIDE

NW124 From a point in line with the common boundary line of numbers 1 and 3 York Road, continuing for a distance of 14 metres in a south-westerly direction.

- 5) The following item NW132 is inserted into Schedule 2 of the Principal Order:-

WOLVERTON ROAD, STONY STRATFORD  
SOUTH-EAST SIDE

NW132 From a point in line with the south-western boundary line of number 14 Wolverton Road, continuing to a point in line with the north-eastern boundary line of number 36 Wolverton Road, a distance of 89 metres in a north-easterly direction.

- 6) The following item NW133 is inserted into Schedule 2 of the Principal Order:-

WOLVERTON ROAD, STONY STRATFORD  
SOUTH-EAST SIDE

NW133 From a point in line with the common boundary line of numbers 46 and 48 Wolverton Road to a point in line with the common boundary line of numbers 80 and 82 Wolverton Road, a distance of 92 metres in a north-easterly direction.

- 7) The following item LW17 is inserted into Schedule 5 of the Principal Order:-

WOLVERTON ROAD  
SOUTH-EAST SIDE

LW17 From a point in line with the common boundary line of numbers 46 and 48 Wolverton Road to a point in line with the north-eastern boundary line of number 36 Wolverton Road, a distance of 40 metres.

**PART 3**

**REVOCATIONS**

6. The following Order is HEREBY REVOKED to the extent stated below:-
