VARIATION ORDER 2014**

The Council of the Borough of Milton Keynes (hereinafter referred to as “the Council”) in exercise of their powers under Sections 45, 46, 49 and 53 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (“the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on 2014 and may be cited as “The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002) Variation Order 2014”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the length of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002 and forms part of that Order.
