VARIATION ORDER 2014**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**PART 1**

**IMPLEMENTATION AND CIATATION**

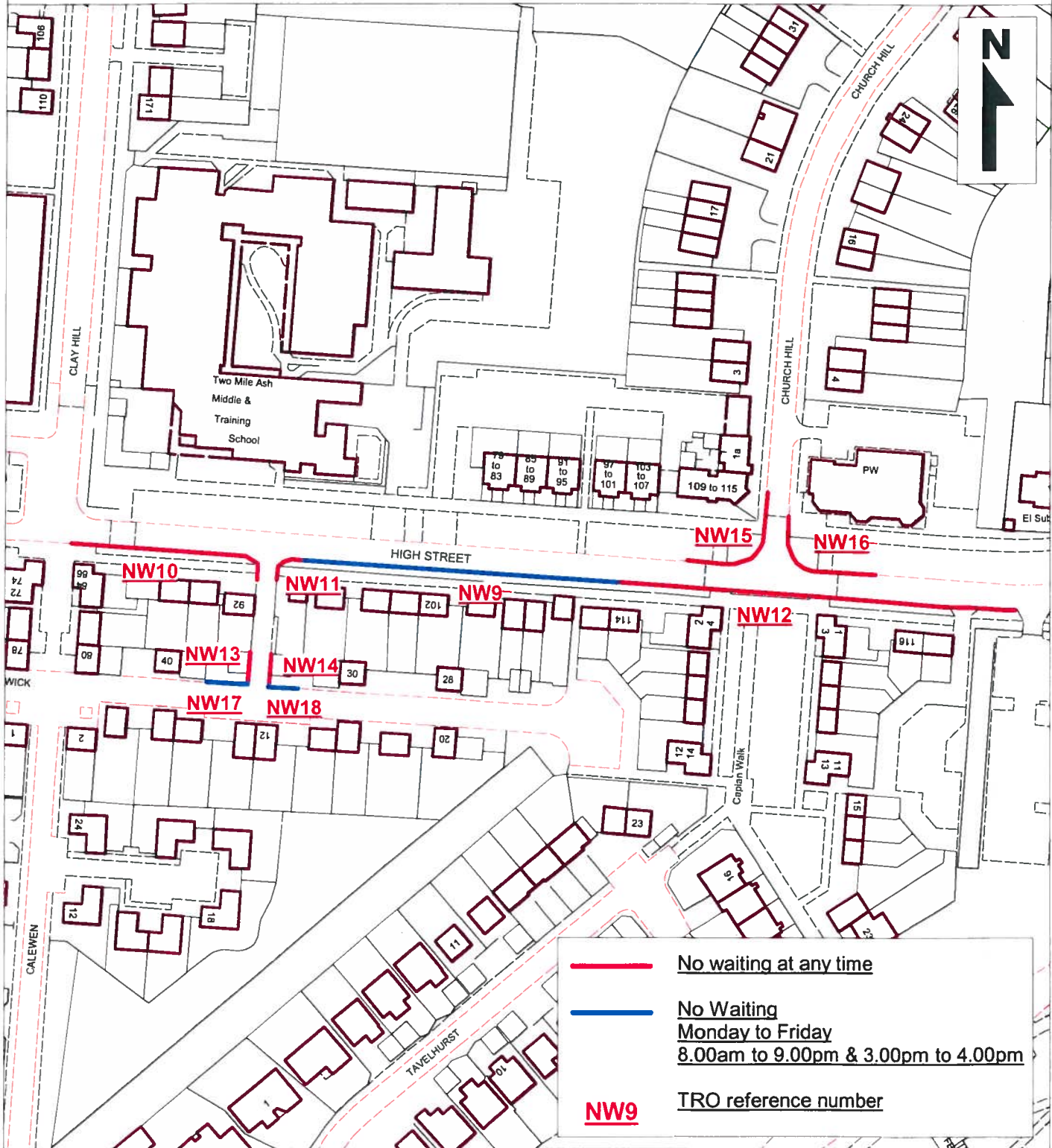
1. This Order shall come into operation on the 14<sup>th</sup> day of August 2014 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Two Mile Ash) (Prohibition and Restriction of Waiting) Order 2011) Variation Order 2014".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Two Mile Ash) (Prohibition and Restriction of Waiting) Order 2011 and form part of that Order.

**PART 2**

**VARIATIONS**

5. The Council of the Borough of Milton Keynes (Various Roads, Two Mile Ash) (Prohibition and Restriction of Waiting) Order 2011 ("The Principal Order") is varied as provided by the following provisions of this Order:-
  
6. Item NW9 in Schedule 3 of the Principal Order is revoked and replaced with the following:-  
**HIGH STREET, TWO MILE ASH  
SOUTH SIDE**  
NW9 From a point 27 metres west of its junction with Church Hill, continuing for a distance of 81 metres in a westerly direction
  
7. The following item NW10 is inserted into Schedule 1 of the Principal Order:-  
**HIGH STREET, TWO MILE ASH  
SOUTH SIDE**  
NW10 From a point 8.5 metres east of the centreline of the junction with Clay Hill for a distance of 48.5 metres in a general eastern then southern direction
  
8. The following item NW11 is inserted into Schedule 1 of the Principal Order:-  
**HIGH STREET, TWO MILE ASH  
SOUTH SIDE**  
NW11 From a point 60 metres east of the centreline of the junction with Clay Hill for a distance of 17.5 metres in a general western then southern direction
  
9. The following item NW12 is inserted into Schedule 1 of the Principal Order:-  
**HIGH STREET, TWO MILE ASH  
SOUTH SIDE**  
NW12 From a point 30 metres west of the centreline of the junction with Church Hill for a distance of 90 metres in a general eastern direction
  
10. The following item NW13 is inserted into Schedule 1 of the Principal Order:-  
**THE ACCESS ROAD THAT LINKS HIGH STREET AND KEPWICK, TWO MILE ASH  
WEST SIDE**  
NW13 From a point in line with the southern boundary line of property 92, High Street, Two Mile Ash, for a distance of 6.5 metres in a general northern direction
  
11. The following item NW14 is inserted into Schedule 1 of the Principal Order:-  
**THE ACCESS ROAD THAT LINKS HIGH STREET AND KEPWICK, TWO MILE ASH  
EAST SIDE**

NW14 From a point in line with the southern boundary line of property 94, High Street, Two Mile Ash, for a distance of 6.5 metres in a general northern direction

12. The following item NW15 is inserted into Schedule 1 of the Principal Order:-

**THE JUNCTION OF CHURCH HILL AND HIGH STREET, TWO MILE ASH  
WEST SIDE AND NORTH SIDE**

NW15 From a point 20 metres north of the centreline of the junction of Church Hill & High Street for a distance of 35.5 metres in a general southern then western direction

13. The following item NW16 is inserted into Schedule 1 of the Principal Order:-

**THE JUNCTION OF CHURCH HILL AND HIGH STREET, TWO MILE ASH  
EAST SIDE AND NORTH SIDE**

NW16 From a point 13 metres north of the centreline of the junction of Church Hill & High Street for a distance of 31 metres in a general southern then eastern direction

14. The following item NW17 is inserted into Schedule 3 of the Principal Order:-

**KEPWICK, TWO MILE ASH  
NORTH SIDE**

NW17 From a point in line with the eastern boundary line of property 36 Kepwick, Two Mile Ash, for a distance of 10.5 metres in a general western direction

15. The following item NW18 is inserted into Schedule 3 of the Principal Order:-

**KEPWICK, TWO MILE ASH  
NORTH SIDE**

NW18 From a point in line with the western boundary line of property 34 Kepwick, Two Mile Ash, for a distance of 8 metres in a general eastern direction
