<u>PART 1</u>

IMPLEMENTATION AND CITATION

- This Order shall come into operation on 2014 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002) Variation Order 2014 (No. 2)".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the length of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevall.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002 and forms part of that Order.

<u>PART 2</u>

VARIATIONS

- 5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. The following additional Schedule is inserted into the Principal Order as follows:-


SCHEDULE 5, PART D

LIMITED WAITING 24 HOURS OF EVERY DAY OF THE WEEK 15-MINUTES, RETURN PROHIBITED WITHIN 1 HOUR EXCEPT WITHIN THE MARKED DISABLED PERSONS' PARKING BAYS

- 7. The following additional Article will be inserted into the Principal Order as follows:-
 - 33c No person shall except with the permission or under the direction of a police officer in uniform or a traffic warden cause or permit any vehicle to wait in any of the parking places in those lengths of road specified in Schedule 5 Part D hereunto 24 hours on any day of the week:
 - (1) For a longer period than 15 minutes; or
 - (2) If a period less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same parking place in the same length of road.

A vehicle which is present in any parking place in any length of road specified in Schedule 5 Part D hereunto at the commencement of the hours of operation of any restrictions imposed by this Order shall be deemed to have been left in that parking place in that length of road at the commencement of that period of operation of that restriction in question.

- 8. The following wording in Article 37
 - 37 "Nothing in Article 6 and 17 above shall render it a contravention of this Order to cause or permit a vehicle to wait in any of the lengths of road
