# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE BOROUGH OF MILTON KEYNES) (VARIOUS ROADS, KNOWHILL) (PROHIBITION OF WAITING) ORDER 2014) VARIATION ORDER 2015

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

## PART 1

# **IMPLEMENTATION AND CIATATION**

- This Order shall come into operation on the day of 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Knowhill) (Prohibition of Waiting) Order 2014) Variation Order 2015".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Knowhill) (Prohibition of Waiting) Order 2014 and form part of that Order.

#### PART 2

### **VARIATIONS**

- 5. The Council of the Borough of Milton Keynes (Various Roads, Knowhill) (Prohibition of Waiting) Order 2014 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. The title of the principal Order is varied to read as follows

- NW2 From a point on Seebeck Place 36.2 metres north of a point in line with the northern kerb line of Davy Avenue, continuing for a distance of 43.7 metres in a southerly then westerly direction
- 8. Item NW22 in Schedule 1 of the principal Order is revoked and replaced by the following:-

SOUTH-WEST AND NORTH-WEST SIDE

- NW22 From a point on Davy Avenue 174.8 metres south-east of its junction with Childs Way (H6), continuing for a distance of 143 metres in a south-easterly then then south-westerly direction




