# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE COUNCIL OF THE BOROUGH OF MILTON KEYNES) (CENTRAL MILTON KEYNES) (ON-STREET FREE AND LIMITED PARKING PLACES AND WAITING RESTRICTIONS) ORDER 2002) VARIATION ORDER 2015

The Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under Sections 32(1), 35(1), 45, 46, 49, 53 and 63 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, ("the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

## PART 1

### **IMPLEMENTATION AND CITATION**

- 1. This Order shall come into operation on 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002) Variation Order 2015".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plans annexed to this Order identify the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Articles it is the wording of the Articles that shall prevail.
- 4. The plans annexed to this Order are hereby annexed to The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002 and form part of the Order.

### PART 2

### **VARIATIONS**

- 5. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Free and Limited Parking Places and Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. The following items are inserted into Schedule 2 of the Principal Order:

THE NORTH-EAST VEHICULAR ACCESSWAY – NORTH-EAST SIDE
FP18 From the south-eastern kerbline of the vehicular access
way, continuing for a distance of 21.3 metres in a northwesterly direction

FP19a Between the access road linking Saxon Gate and the entrance of the multi-storey car park to the access road linking Saxon Gate and the exit of the multi-storey car park




