The Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under Sections 45, 46, 49 and 53 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, ("the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Premium Rate and Long Stay Pay and Display and Pay by Mobile Phone Parking Places) Order 2002) Variation Order 2015".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

VARIATIONS

3. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Premium Rate and Long Stay Pay and Display and Pay by Mobile Phone Parking Places) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-

**EXCEPT WITHIN THE MARKED BICYCLE / MOTOR CYCLE AND
DISABLED PERSONS' PARKING PLACES**

BETWEEN 7.00AM AND 6.00PM ON EVERY DAY OF THE WEEK
