

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE
COUNCIL OF THE BOROUGH OF MILTON KEYNES) (VARIOUS
ROADS, OXLEY PARK) (PROHIBITION OF WAITING AND LOADING
RESTRICTIONS) ORDER 2012) VARIATION ORDER 2015**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the day of 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Oxley Park) (Prohibition of Waiting and Loading Restrictions) Order 2012) Variation Order 2015".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Oxley Park) (Prohibition of Waiting and Loading Restrictions) Order 2012 and form part of that Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Various Roads, Oxley Park) (Prohibition of Waiting and Loading Restrictions) Order 2012 (“The Principal Order”) is varied as provided by the following provisions of this Order:-
6. The following items are inserted into Schedule 1 of the principal Order:-

HARLOW CRESCENT, OXLEY PARK

NORTH-WEST SIDE

NW6 From a point 72.6 metres east of the centreline of Tierney, for a distance of 23.9 metres in a north-easterly direction

HARLOW CRESCENT, OXLEY PARK

SOUTH-WEST SIDE

NW7 From its junction with Whitney Roundabout, for a distance of 86.1 metres in a north-westerly then westerly direction

HARLOW CRESCENT, OXLEY PARK

NORTH-EAST SIDE

NW8 From its junction with Whitney Roundabout, for a distance of 68.4 metres in a north-westerly then north-easterly direction
