

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES
(STATION SQUARE, CENTRAL MILTON KEYNES)
(PROHIBITION OF RIGHT TURN) ORDER 2015**

WHEREAS the Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1) to (3) of the Road Traffic Regulation Act 1984, (the Act of 1984) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

PART 1

COMMENCEMENT AND CITATION

1. This Order shall come into operation on the 18th day of June 2015 and may be cited as the Council of the Borough of Milton Keynes (Station Square, Central Milton Keynes) (Prohibition of Right Turn) Order 2015.

PART 2

PROHIBITION OF RIGHT TURN

2. No person shall cause or permit any vehicle to be driven in such a way so as to perform a Right-turn manoeuvre in the length of road specified in Column 1 of the Schedule to this Order into the length of road specified in Column 2 of the said Schedule.
3. Nothing in Article 2 of this Order, shall render it unlawful to cause or permit any vehicle, if it cannot conveniently be used for such purpose in any other road, to make a Right-turn manoeuvre from the length of road specified in Column 1 of the Schedule of this Order into the length of road specified in Column 2 of the said Schedule if the vehicle is being used for police, fire brigade or ambulance purposes or by military vehicles on operational duties.
4. The plan annexed to this Order identifies the area of road described in the Schedule to this Order, provided that where there is any inconsistency between the plan and that Schedule, it is the wording of that Schedule which shall prevail.
