The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

- This Order shall come into operation on the day of 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Bradwell Common) (Prohibition of Waiting and Loading) Order 2013) Variation Order 2015".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Bradwell Common) (Prohibition of Waiting and Loading) Order 2013 and form part of that Order.

PART 2

VARIATIONS

- 5. The Council of the Borough of Milton Keynes (Various Roads, Bradwell Common) (Prohibition of Waiting and Loading) Order 2013 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. The following items are inserted into Schedule 1 of the Principal Order:-

BRADWELL COMMON BOULEVARD

NORTH-WEST SIDE

NW6 From a point 29.2 metres north-east of a point in line with the with the north-eastern kerb line of V6 Grafton Street, continuing for a distance of 63 metres in a north-easterly and north-westerly direction

BRADWELL COMMON BOULEVARD AND BRILL PLACE

NORTH-WEST SIDE AND SOUTH-WEST SIDE

NW7 From a point on Bradwell Common Boulevard 89.2 metres north-east of a point in line with the with the north-eastern kerb line of V6 Grafton Street, continuing for a distance of 88 metres in a south-easterly, north-easterly and north-westerly direction into Brill Place

BRADWELL COMMON BOULEVARD

SOUTH-EAST SIDE

NW8 From a point 5.2 metres north-east of a point in line with the with the north-eastern kerb line of V6 Grafton Street, continuing for a distance of 137.3 metres in a north-easterly, south-easterly and south-westerly direction

BRADWELL COMMON BOULEVARD

SOUTH-EAST SIDE TRAFFIC ISLAND

NW9 From a point 7.3 metres south-east of a point in line with the with the south-eastern kerb line of Bradwell Common Boulevard access road continuing for a distance of 26 metres in a north-westerly, north-easterly and south-easterly direction following the kerb line of the traffic island

BRADWELL COMMON BOULEVARD

SOUTH-EAST SIDE TRAFFIC ISLAND

NW10 From a point 6.8 metres north-west of a point in line with the north-western kerb line of the access road to the CMK Medical Centre continuing for a distance of 26 metres in a south-easterly, north-easterly and north-westerly direction following the kerb line of the traffic island

BRILL PLACE AND BRADWELL COMMON BOULEVARD ACCESS ROAD NORTH-EAST SIDE AND NORTH-WEST SIDE

NW11 From a point on Brill Place 13 metres north-west of a point in line with the with the north-western kerb line of Bradwell Common Boulevard access road continuing for a distance of 21.6 metres in a south-easterly and north-easterly direction on to Bradwell Common Boulevard access road
