PART 1

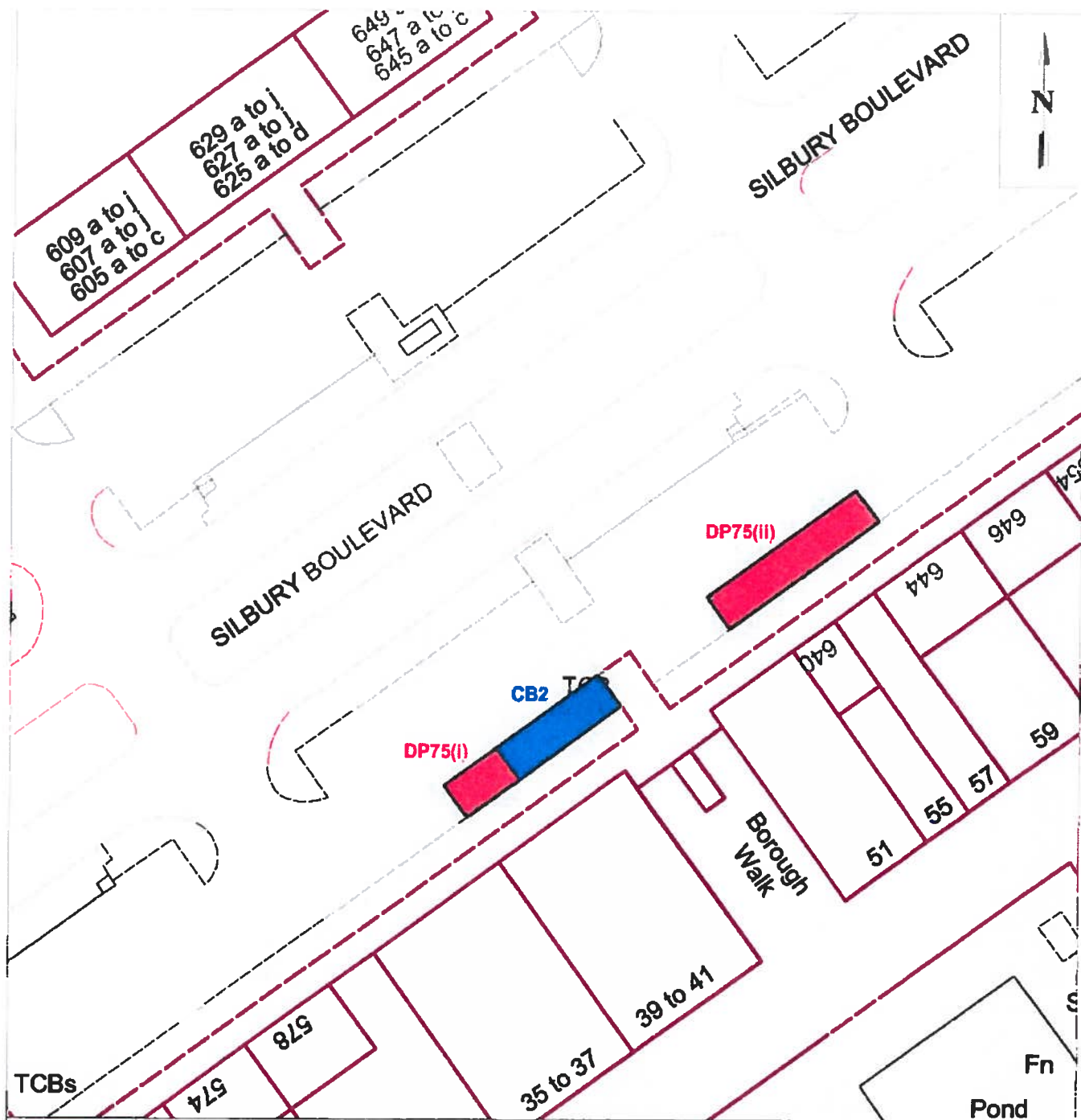
IMPLEMENTATION AND CITATION





1. This Order shall come into operation on the 11th day of January 2016 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002) Variation Order 2016".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002 and forms part of that order.

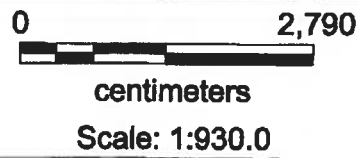

6. Item DP75 in schedule 6 of the Principal Order is revoked and replaced with the following:-

SILBURY BOULEVARD

THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE

DP75(i) From a point 14.6 metres south-west of the south-western side of the porte cochere leading to Borough Walk, continuing for a distance of 7.4 metres in a south-westerly direction (2 SPACES)

SILBURY BOULEVARD

THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE

DP75(ii) From a point 10.5 metres north-east of the north-eastern side of the porte cochere leading to Borough Walk, continuing for a distance of 14.6 metres in a north-easterly direction (4 SPACES)

7. Item CB2 in schedule 9 of the Principal Order is revoked and replaced with the following:-

SILBURY BOULEVARD

THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE

CB2 From the south-western side of the porte cochere leading to Borough Walk, continuing for a distance of 14.6 metres in a south-westerly direction
