
# THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (A5130 NEWPORT ROAD, MILTON KEYNES) (40 MPH SPEED RESTRICTION) ORDER 2016

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 82(2), 83(2), 84(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

# PART 1

# **IMPLEMENTATION AND CIATATION**

- 1. This Order shall come into operation on the ..... day of ......... 2015 and may be cited as "The Council of the Borough of Milton Keynes (A5130 Newport Road, Milton Keynes) (40 Mph Speed Restriction) Order 2016".
- 2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 1 to this Order.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (A5130 Newport Road, Milton Keynes) (40 Mph Speed Restriction) Order 2015 and form part of that Order.
- 5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order any provisions of any Orders mentioned in Schedule 2 hereto are hereby revoked to the extent stated in that Schedule.
