The Council of the Borough of Milton Keynes ("the Council") In exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the 14th day of December 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Bletchley) (Consolidation of Parking and Waiting Restrictions and Prohibition of Loading) Order 2002) Variation Order 2015".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Bletchley) (Consolidation of Parking and Waiting Restrictions and Prohibition of Loading) Order 2002

6. The following items are inserted into SCHEDULE 1 of the Principal Order:-

BYRON CLOSE AND MILTON ROAD

SOUTH SIDE AND WEST SIDE

NW201 From a point on Byron Close 19.8 metres west of its junction with Milton Road, continuing for a distance of 32.2 metres in a generally easterly then southerly direction onto Milton Road

MILTON ROAD AND BYRON CLOSE

WEST SIDE AND NORTH SIDE


NW202 From a point on Milton Road at its junction with the southern kerbline of Buckingham Road, continuing for a distance of 44.5 metres in a generally southerly then westerly direction onto Byron Close

MILTON ROAD

EAST SIDE

NW203 From its junction with the southern kerbline of Buckingham Road, continuing for a distance of 45.6 metres in a generally southerly direction
