

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE
COUNCIL OF THE BOROUGH OF MILTON KEYNES) (CENTRAL
MILTON KEYNES) (ON-STREET SPECIFIC AND PERMIT PARKING
PLACES) ORDER 2002) VARIATION ORDER 2016 (No.2)**

The Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under Sections 32(1), 35(1), 45, 46, 49, 53 and 63 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, ("the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on the 18th day of July 2016 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002) Variation Order 2016 (No.2)".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and the Articles it is the wording of the Articles which shall prevail.
4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002 and forms part of that order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Specific and Permit Parking Places) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
6. Item DP76 in schedule 6 of the Principal Order is revoked and replaced with the following:-

SILBURY BOULEVARD

THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE

- DP76** From a point 34.8 metres north-east of the north-eastern side of the porte cochere leading to Crown Walk, continuing in a north-easterly direction to the south-western kerbline of the footway leading to Deer Walk (12 SPACES)

7. The following item DP129 is inserted into Schedule 6 of the Principal Order:-

SILBURY BOULEVARD

THE SOUTH-EAST VEHICULAR ACCESSWAY – SOUTH-EAST SIDE

DP129 From the north-eastern kerbline of the footway leading to Deer Walk,
continuing for a distance of 37.4 metres in a south-westerly direction
(7 SPACES)
