

**THE COUNCIL OF THE BOROUGH OF MILTON KEYNES (THE
COUNCIL OF THE BOROUGH OF MILTON KEYNES) (CHADWICK
DRIVE, EAGLESTONE) (PROHIBITION OF WAITING) ORDER 2009)
VARIATION ORDER 2017**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

1. This Order shall come into operation on the 8th day of May 2017 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Chadwick Drive, Eaglestone) (Prohibition of Waiting) Order 2009) Variation Order 2017".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
4. The plans annexed to this Order is hereby annexed to "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Chadwick Drive, Eaglestone) (Prohibition of Waiting) Order 2009) Variation Order 2017" and forms part of that Order.

PART 2

VARIATIONS

5. The Council of the Borough of Milton Keynes (Chadwick Drive, Eaglestone) (Prohibition of Waiting) Order 2009 ("The Principal Order") is varied as provided by the following provisions of this Order:-
6. Item NW4 in Schedule 1 of the principal Order is replaced by the following:-

CHADWICK DRIVE
SOUTH SIDE

NW4 From a point approximately 75.4 metres north-east of its junction with Saxon Street, continuing for a distance of approximately 43.3 metres in a generally north-easterly direction

NW7 From the south-eastern kerbline of the entrance gates to Saxon Clinic, continuing for a distance of approximately 114 metres in a generally south-eastern direction, including the cul-de-sac.

8. Item NW8 in Schedule 1 of the principal Order is replaced by the following:-

CHADWICK DRIVE
EAST SIDE

NW8 From a point approximately 175.5 metres north-east of its junction with Saxon Street, continuing for a distance of approximately 52 metres in a generally south-easterly direction

9. Item NW14 in Schedule 1 of the principal Order is replaced by the following:-

CHADWICK DRIVE
EAST SIDE

NW14 From a point in line with the northern kerbline of the north-western vehicular entrance to Chadwick Lodge, continuing for a distance of approximately 29.8 metres in a generally north-westerly direction

10. The following item NW20 is inserted into Schedule 1 of the principal Order:-

CHADWICK DRIVE
EAST SIDE

NW20 From a point approximately 102 metres south-east of a point approximately 175.5 metres north-east of its junction with Saxon Street, continuing for a distance of approximately 4 metres in a south-easterly direction
