# PART 1

- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

### PART 2

## **VARIATIONS**

3. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display and Pay by Mobile Phone and Electric Vehicle Parking Places) Order 2013 ("The Principal Order") is varied as provided by the following provisions of this Order:-

- 4. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Articles 11, 12, 12(1), 12(2) and 13 in Part 3 of the principal Order.
- 5. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Article 27(4) in Part 4 of the principal Order.
