- 5. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Articles 27(2), 27(2)(a), 27(2)(b) and 27(3) in Part 4 of the principal Order.
- The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be 6. removed from Article 45(4) in Part 5 of the principal Order.
- 7. The wording "Employee Permit Scratch-Card (Full Day)" and "Employee Permit Scratch-Card (Half Day)" shall be removed from the title of Schedule 4A of the Principal Order
