PERMITS) ORDER 2002) VARIATION ORDER 2017**

The Council of the Borough of Milton Keynes (hereinafter referred to as “the Council”) in exercise of their powers under Sections 45, 46, 49 and 53 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (“the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on 1st April 2017 and may be cited as “The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Central Milton Keynes) (On-Street Standard Rate Pay and Display and Pay by Mobile Phone and Various Permits) Order 2002) Variation Order 2017”.
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

PART 2

VARIATIONS

3. The Council of the Borough of Milton Keynes (Central Milton Keynes) (On-Street Standard Rate Pay and Display and Pay by Mobile Phone and Various Permits) Order 2002 (“The Principal Order”) is varied as provided by the following provisions of this Order:-
4. The wording “Employee Permit Scratch-Card” and “Scratch-Cards” shall be removed from Articles 11, 11(a), 12, 12(1), 12(2), and 13 in Part 2 of the principal Order.

5. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Articles 27(2), 27(2)(a), 27(2)(b) and 27(3) in Part 4 of the principal Order.
6. The wording "Employee Permit Scratch-Card" and "Scratch-Cards" shall be removed from Article 45(4) in Part 5 of the principal Order.
7. The wording "Employee Permit Scratch-Card (Full Day)" and "Employee Permit Scratch-Card (Half Day)" shall be removed from the title of Schedule 4A of the Principal Order

PART 3

REVOCATIONS

8. The following Order is HEREBY REVOKED to the extent stated below:-

Items 3 and 4 in Schedule 6 ARE HEREBY REVOKED IN ITS ENTIRETY.

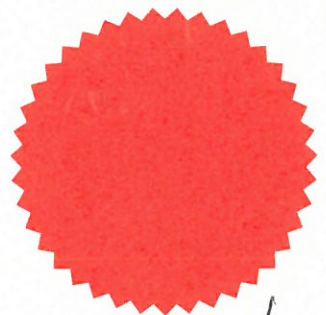
