(ON-STREET FREE AND LIMITED PARKING PLACES) ORDER 2018)
VARIATION ORDER 2019**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1, 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on the 15th day of March 2019 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Station Square, Central Milton Keynes) (On-Street Free and Limited Parking Places) Order 2018) Variation Order 2019".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

PART 2

VARIATIONS

3. The Council of the Borough of Milton Keynes (Station Square, Central Milton Keynes) (On-Street Free and Limited Parking Places) Order 2018 ("The Principal Order") is varied as provided by the following provisions of this Order:-
4. Article 17 in Part 3 of the Principal Order is replaced by the following:-

17. No person shall except with the permission or under the direction of a police officer in uniform, a traffic warden or a civil enforcement officer, cause or permit any vehicle to wait in any of the parking places in those lengths of road specified in Schedule 1 hereto at any time:

- (1) for a longer period than 5 minutes; or
- (2) if a period less than 40 minutes has elapsed since the termination during the said hours of the last period of waiting (if any) by that vehicle in the same parking place in the same length of road.

A vehicle which is present in any parking place in any length of road specified in Schedule 1 hereto at the commencement of the hours of operation of any restrictions imposed by this Order shall be deemed to have been left in that parking place in that length of road at the commencement of that period of operation of the restriction in question.

5. The title Schedule 1 of the Principal Order is replaced with the following:-

SCHEDULE 1

FREE LIMITED WAITING PARKING PLACES


THE WHOLE 24 HOURS OF EVERY DAY OF THE WEEK
FOR A MAXIMUM PERIOD OF 5 MINUTES
RETURN PROHIBITED WITHIN 40 MINUTES

EXCEPT WITHIN THE MARKED BICYCLE/MOTOR CYCLE AND DISABLED
PERSONS' PARKING BAYS
