PART 1

- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002 and form part of that Order.

PART 2

<u>VARIATIONS</u>

5. The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-

Item NW151 in Schedule 1 of the Principal Order is revoked and replaced by the following:-

MILL STREET, NEWPORT PAGNELL **SOUTH-WEST SIDE**

From a point in line with the shared boundary line of numbers 2 NW151 and 2a Mill Street, for a distance of 29.5 metres in a northwesterly direction
