The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

## PART 1

## **IMPLEMENTATION AND CIATATION**

- This Order shall come into operation on the 1<sup>st</sup> day of April 2017 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Newport Pagnell) (Prohibition and Restriction of Waiting) Order 2009) Variation Order 2017".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Prohibition and Restriction of Waiting) Order 2009 and form part of that Order.

#### PART 2

#### **VARIATIONS**

- 5. The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Prohibition and Restriction of Waiting) Order 2009 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. Item NW12 in Schedule 1 of the principal Order is replaced by the following:-

THE JUNCTION OF THE CANONS AND TICKFORD STREET NORTH-WEST SIDE AND NORTH-EAST SIDE

NW12 From a point on The Canons 36 metres north-east of the north-eastern kerbline of Tickford Street, for a distance of 46 metres in a south-westerly then north-westerly direction onto and along Tickford Street
