

THE COUNCIL OF THE BOROUGH OF MILTON KEYNES
(H6 CHILDS WAY JUNCTIONS WITH FORTESCUE DRIVE, SHENLEY
CHURCH END AND LIVESLEY HILL, SHENLEY LODGE) (PROHIBITION OF
RIGHT TURN) ORDER 2015

WHEREAS the Council of the Borough of Milton Keynes (hereinafter referred to as "the Council") in exercise of their powers under sections 9, 10(2), 2(1) to (3) of the Road Traffic Regulation Act 1984, (the Act of 1984) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

PART 1

IMPLEMENTATION AND CITATION

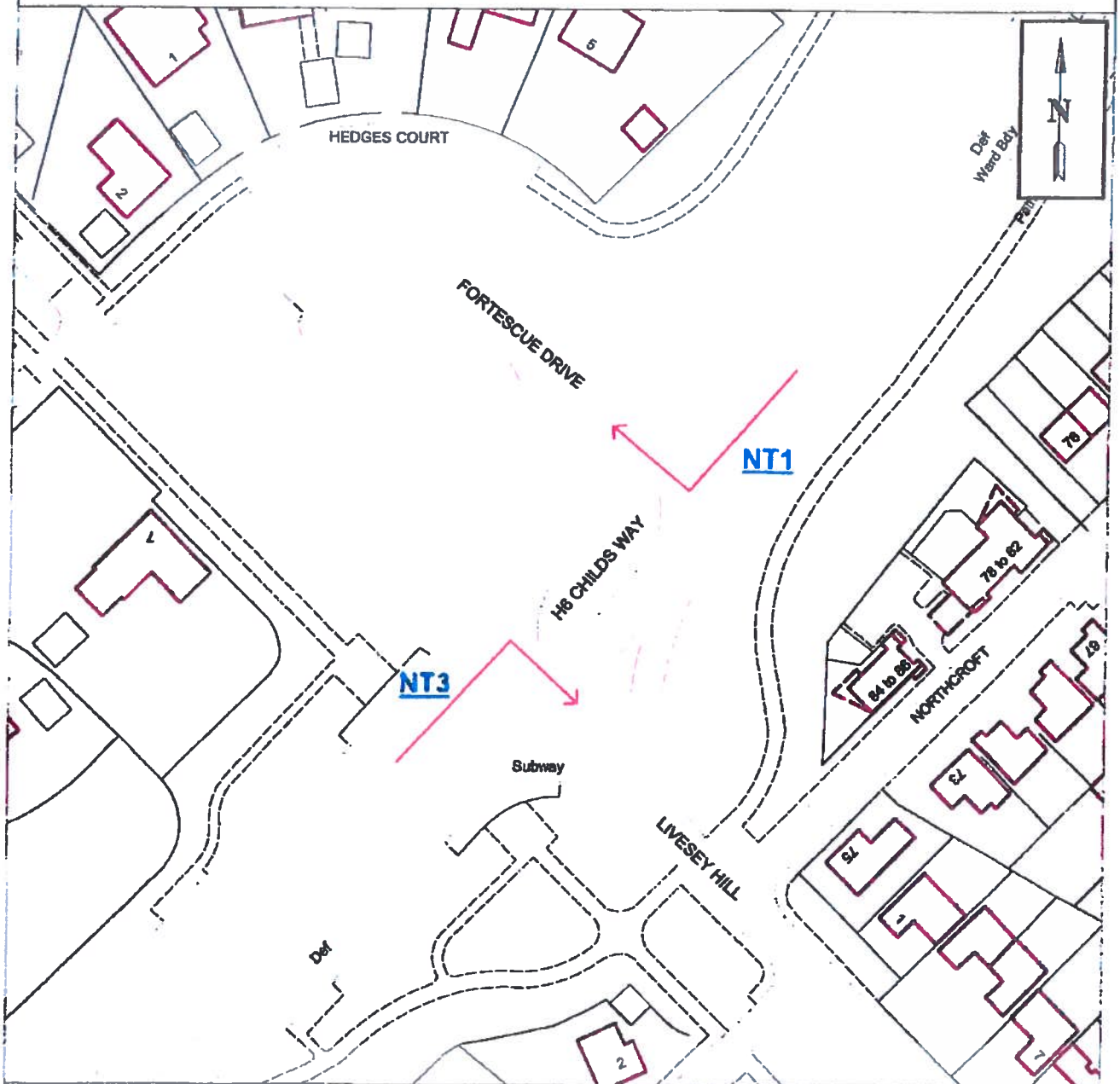
1. This Order may be cited as "The Council of the Borough of Milton Keynes (H6 Childs Way junctions with Fortescue Drive, Shenley Church End and Livesley Hill, Shenley Lodge) (Prohibition of Right Turn) Order 2015" and shall come into force on the 7th day of September 2015.
2. The plan annexed to this Order identifies the lengths of road described in Schedule 1 to this Order, provided that where there is any inconsistency between the plan and the Schedule, it is the wording of the Schedule which shall prevail.

PART 2

PROHIBITION OF RIGHT TURN EXCEPT BUSES

3. No person shall cause or permit any vehicle to be driven in such a way unless that vehicle is a bus so as to perform a right-turn manoeuvre in the length of road specified in Column 1 of Schedule 1 to this Order into the length of road specified in Column 2 of the said Schedule.
4. Nothing in Article 3 of this Order, shall render it unlawful to cause or permit any vehicle, if it cannot conveniently be used for such purpose in any other road, to make a right-turn manoeuvre in the length of road specified in Column 1 of

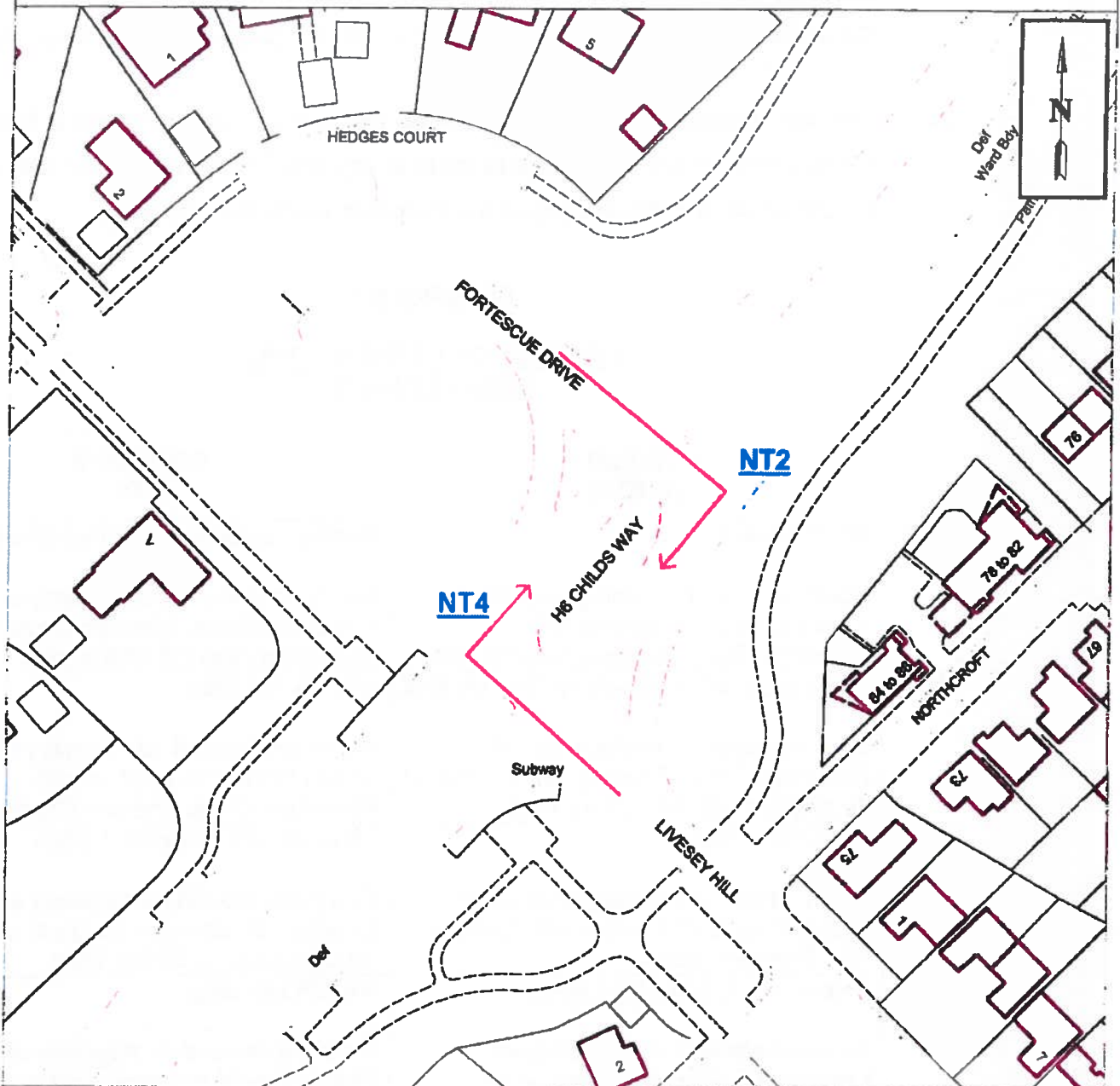
