The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under sections 1(1), 2(1) and (2), 4(2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, herby makes the following Order:-

PART 1

IMPLEMENTATION AND CIATATION

- This Order shall come into operation on the 7th day of September 2015 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes) (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002) Variation Order 2015".
- 2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plan and Schedules it is the wording of the Schedules which shall prevail.
- 4. The plan annexed to this Order is hereby annexed to The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002 and form part of that Order.

PART 2

VARIATIONS

- 5. The Council of the Borough of Milton Keynes (Various Roads, Newport Pagnell) (Consolidation of Parking and Waiting Restrictions) Order 2002 ("The Principal Order") is varied as provided by the following provisions of this Order:-
- 6. Article 7 of the principal Order is revoked and replaced by the following:-
 - 7. (1) No person shall except with the permission or under direction of a police officer in uniform or a traffic warden cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm, Monday to Saturday in the lengths of road specified in Schedule 2 hereto.
 - (2) No person shall except with the permission or under direction of a police officer in uniform or a traffic warden cause or permit any vehicle to wait between the hours of 8.30am and 9.15am and 2.30pm and 3.30pm, Monday to Friday in the lengths of road specified in Schedule 2A hereto.
- 7 Article 16 of the principal Order is revoked and replaced by the following:-
 - 16. (1) No person shall except with the permission or under direction of a police officer in uniform or a traffic warden cause or permit any vehicle to load or unload between the hours of 8.15am and 9.00am, Monday to Saturday in the lengths of road specified in Schedule 11 hereto.
 - (2) No person shall except with the permission or under direction of a police officer in uniform or a traffic warden cause or permit any vehicle to load or unload between the hours of 8.30am and

9.15am and 2.30pm and 3.30pm, Monday to Friday in the lengths of road specified in Schedule 11A hereto.






