AMENDMENT ORDER 2008**

The Council of the Borough of Milton Keynes ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

PART 1

IMPLEMENTATION AND CITATION

1. This Order shall come into operation on the 7 day of March 2008 and may be cited as "The Council of the Borough of Milton Keynes (The Council of the Borough of Milton Keynes (Various Roads, West Bletchley) (Consolidation of Parking and Waiting Restrictions) Order 2002) Amendment Order 2008".
2. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
3. The plan annexed to this Order identifies the lengths of road subject to this Order, provided that where there is any inconsistency between the plans and the Schedules it is the wording of the Schedules which shall prevail.

PART 2

AMENDMENTS

1. The Council of the Borough of Milton Keynes (Various Roads, West Bletchley) (Consolidation of Parking and Waiting Restrictions) Order 2002 ("the Principal Order") is hereby amended to the extent stated below:

(1)The following item is inserted into Schedule 1

NW40 SHERWOOD DRIVE, EAST SIDE

From a point 7metres south of the Southern kerbline of Turning Gate for a distance of 86m in a Northerly direction.

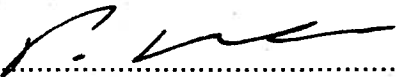
NW41 TURING GATE, BOTH SIDES

From its junction with Sherwood Drive for a distance of 48 metres in a westerly direction.

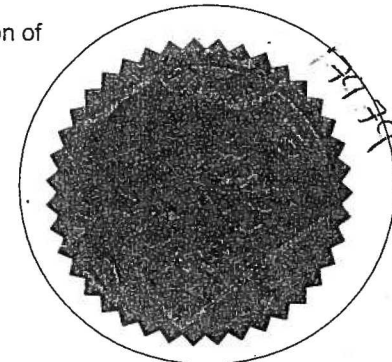
