### **THE MOLE VALLEY DISTRICT COUNCIL (OFF-STREET PARKING PLACES)(AMENDMENT NO. 8) ORDER 2006**

The Mole Valley District Council ("the Council") in exercise of its powers under Section 35(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and under the Road Traffic Act 1991("the 1991 Act"), and of all other enabling powers, with the consent of the Surrey County Council in accordance with Section 39(3) of the Act and after consulting the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

#### **PART I**

#### **GENERAL**

##### **Commencement and Citation**

1. (1) This Order shall come into operation on the 8th day of May 2007 and may be cited as the Mole Valley District Council (Off-Street Parking Places) (Amendment No. 8) Order 2006.
- (2) The Mole Valley District Council (Off-Street Parking Places) Order 1997, as amended, is hereby further amended and shall be construed as and where necessary in accordance with the provisions of this Order.
