ORDER 2007

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:

1. This Order shall come into operation on the 26th day of March 2007 and may be cited as the "Neath Port Talbot County Borough Council (Accident Reduction Scheme) (Fairyland, Neath) Order 2007.
2. (1) In this Order –
 - "Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;
 - "Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;
 - "Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;
 - "Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;
 - "Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;
 - "Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Service Act 2000.
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

3. Save as provided in Articles 5, 6, 7 and 8 of this Order no person except at the direction of a Police Constable in uniform or of a Parking Attendant shall cause or permit any vehicle to wait at any time on the lengths of sides of roads as set out in the Schedule to this Order.
4. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the lengths of sides of the roads referred to in the Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same length of side of roads on which that vehicle had previously been waiting).
5. Nothing in Article 3 of this Order shall render it unlawful to case or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable:
 - (A) A person to board or alight from a vehicle;
 - (B) The vehicle, if it cannot conveniently be used in connection with any of the following operations namely;
 - (i) building, industrial or demolition operations;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road or any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (C) The vehicle , if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (D) The vehicle to be used by a Universal Service Provider for the purpose of deliveries or collecting postal packets;
 - (E) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
 - (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.

6. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable goods to be loaded or unloaded from the vehicle.
7. The prohibitions imposed by Article 3 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

SCHEDULE

No Waiting At Any Time

- i) **Fairyland, Neath**
North Side
Between points approximately 130 metres and 146 metres east of its junction with Gnoll Bank.
- ii) **Harle Street, Neath**
East Side
From its junction with Glen Road for a distance of approximately 6 metres in a northerly and southerly direction.
- iii) **Glen Road, Neath**
 - (a) **Both Sides**
From its junction with Harle Street for a distance of approximately 6 metres in an easterly direction.
 - (b) **Both Sides**
From its junction with Digby Road for a distance of approximately 6 metres in a westerly direction.
- iv) **Digby Road, Neath**
 - (a) **West Side**
From its junction with Glen Road for a distance of approximately 8 metres in a northerly and southerly direction.
 - (b) **West Side**
From its junction with Leonard Street for a distance of approximately 4 metres in a northerly and southerly direction.
- v) **Digby Road, Neath**
 - (a) **East Side**
From its junction with Illtyd Street for a distance of approximately 8 metres in a northerly and southerly direction.

(b) **East Side**

From its junction with Idwal Street for a distance of approximately 6 metres in a northerly and southerly direction.

vi) **Illtyd Street, Neath**

Both Sides

From its junction with Digby Road for a distance of approximately 8 metres in an easterly direction.

vii) **Idwal Street, Neath**

Both Sides

From its junction with Digby Road for a distance of approximately 6 metres in an easterly direction.

viii) **Leonard Street, Neath**

Both Sides

From its junction with Digby Road for a distance of approximately 4 metres in a westerly direction.
