(LIMITED WAITING AND REVOCATION) ORDER 1984

The West Glamorgan County Council in exercise of their powers under Section 1(1), (2) and (3) and Section 84 D (1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act 1972 Schedule 6 of the Road Traffic Act 1974 and Schedule 7 to the Local Government Planning and Land Act 1980 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 84(C) 1 of the Act of 1967, hereby make the following Order.

1. This Order shall come into operation on the 27th day of MAY 1984 and may be cited as "The West Glamorgan County Council (Alfred Street, Neath) (Limited Waiting and Revocation) Order 1984".

2. (1) In this Order:-

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1975;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS. No. 4631-1970), coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, and

"relevant position" means:

(i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen;

(ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or nearside of the vehicle

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. The undermentioned Orders are hereby revoked insofar as they relate to any of the lengths or sides of roads specified in the Schedule to this Order:-
 - (a) The West Glamorgan County Council (Various Streets, Neath) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1976 made by the West Glamorgan County Council 17th March 1976;
 - (b) West Glamorgan County Council (Alfred Street, Neath) (Public Service Vehicles Stand) and (Restriction of Waiting) Order 1976 made by the West Glamorgan County Council on 2nd April 1976.
4. Save as provided in Articles 5, 6 and 7 of this Order no person shall, except upon the direction of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait for more than 1 hour, no return permitted within 1 hour, from Monday to Saturday inclusive between 8.00 a.m. and 6.00 p.m. on the length or lengths of roads specified in the Schedule to this Order.
5. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the side of road specified therein for so long as may be necessary to enable:-
 - (i) a person to board or alight from the vehicle;
 - (ii) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (a) building, industrial or demolition operations;
 - (b) the removal of any obstruction to traffic;
 - (c) the maintenance, improvement or reconstruction of the side of road; or
 - (d) the laying, erection, alteration or repair in or in land adjacent to the said side of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878; or
 - (iii) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - (iv) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
 - (v) the vehicle to be used for Police, ambulance or fire brigade purposes.

6. Nothing in Article 4 of this Order shall render it unlawful for goods to be loaded or unloaded from a vehicle, waiting on the length of road specified therein.
7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the side of road referred to in the said Article for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of road).
8. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1967 or by or under any other enactment.

SCHEDULE

Alfred Street (South Side) Neath

From a point 90 metres or thereabouts from its junction with Windsor Road for a distance of 28 metres or thereabouts in an easterly direction.
