(REVOCATION)
ORDER 2013

The Neath Port Talbot County Borough Council in exercise of its powers under Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984) and of all other powers then enabling and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order shall come into operation on the 28th day of March 2013 and may be cited as the “Neath Port Talbot County Borough Council (Hafod Street, Port Talbot) and (Bethlehem Road, Skewen) (Revocation) Order 2013”.
2. (1) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The provisions contained in Article 5 of Schedule 2 (Residents Only Parking At Any Time) of the Neath Port Talbot County Borough Council (Various Streets in Neath, Melyn, Briton Ferry and Port Talbot) (Residents Parking and Prohibition of Waiting At Any Time) Order 1997 are hereby revoked only insofar as they relate to the side and lengths of road specified in Schedule 1 of this Order.
4. The provisions contained in Article 1 of Schedule 6 (Waiting Limited to 1 Hour Return Prohibited within 1 Hour, 8am-6pm Monday to Saturday with Exemption for Residents) of the West Glamorgan County Council (Skewen/Neath Abbey Traffic Management Scheme) (Phase I) Order 1994 are hereby revoked only insofar as the relate to the sides and lengths of road specified in Schedule 2 of this Order.

SCHEDULES

Schedule 1 – Revocation of Residents Only Parking

Hafod Street, Port Talbot

South West Side

From a point approximately 47 metres south-east of the south eastern kerbline of Dan y Bryn Road for a distance of approximately 22 metres in a south easterly direction.

North East Side

- A. From a point 11 metres (approximately) south-east of the south eastern kerbline of Dan y Bryn Road for a distance of approximately 18 metres in a south easterly direction.

- B. From a point 94metres (approximately) south-east of the south eastern kerbline of Dan y Bryn Road for a distance of approximately 18metres in a south-easterly direction.

Schedule 2 – Revocation of Waiting Limited to 1 Hour Return Prohibited Within 1 Hour 8am-6pm Monday to Saturday with Exemption for Residents

Bethlehem Road

North Side

Between points approximately 5 metres and 59 metres north west of its junction with Brook Street.

South Side

Between points approximately 90 metres and 125 metres north west of its junction with Old Road.
