**Cimla Road, Neath at Junction with the Lane,
alongside Post Office, leading to Moorland Road
(Both Sides).**

From the south west side of the lane for a distance of 10 metres
in a south westerly direction.

From the north east of the lane for a distance of 10 metres in a
north easterly direction.

**Cimla Road, Neath at the junction with the Lane,
alongside the Cimla Hotel leading to Moorland Road
(South East Side).**

From the south west side of the lane for a distance of 10 metres
in a south westerly direction.

From the north east side of the lane for a distance of 10 metres
in a north easterly direction.

**Lane, alongside Post Office linking
Cimla Road to Moorland Road.
(Both Sides).**

From the south east side of Cimla Road to the north west side of
Moorland Road.

**Lane alongside Cimla Hotel, linking
Cimla Road to Moorland Road.
(Both Sides).**

From the south east side of Cimla Road to the north west side of
Moorland Road.
