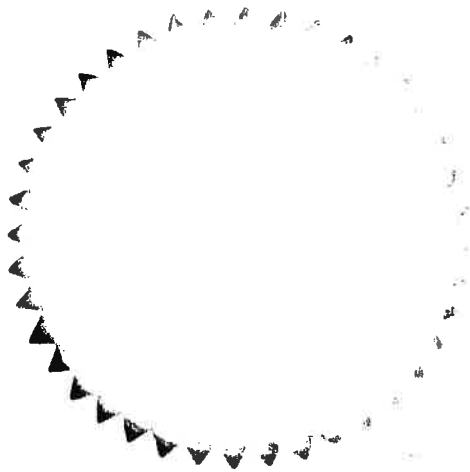

The West Glamorgan County Council in exercise of their powers under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972, and Schedule 6 of the Road Traffic Act, 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 84 C (1) of the Act of 1967, hereby make the following Order -

- 3. Articles 3 and 4 of the "West Glamorgan County Council (Various Streets, Glynneath) (Revocation and Prohibition of Waiting, Loading and Unloading) Order 1975" made by the West Glamorgan County Council on 31 July, 1975 are hereby revoked.

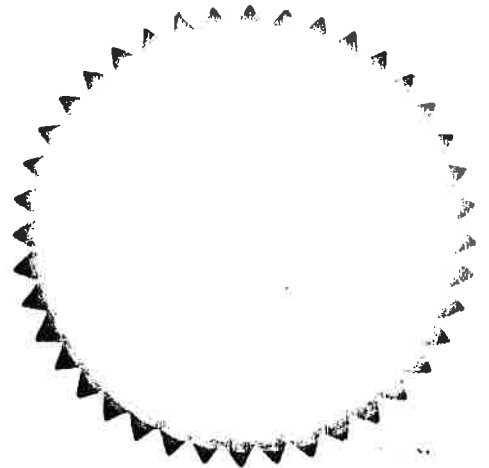

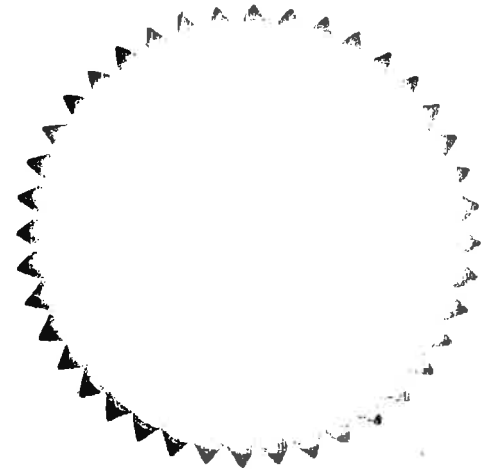
