**(REVOCAATION) (PROHIBITION OF WAITING, LOADING AND**  
**UNLOADING AT ANY TIME) AND (PROHIBITION OF WAITING AT ANY**  
**TIME)**

**ORDER 2017**

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order shall come into operation on the 20th day of January 2017 and may be cited as the "Neath Port Talbot County Borough Council (Green Park Street, Water Street and Afan Way, Port Talbot) (Revocation) (Prohibition of Waiting, Loading and Unloading At Any Time) and (Prohibition of Waiting At Any Time) Order 2017".

2. (1) In this Order –

"Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) (Amended) Regulations 2000;

"Disabled Persons Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;

"Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;

"Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;

"Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;

"Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.

- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
  - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The provisions in the Orders set out in Schedule 1 are hereby revoked in so far as they relate to the roads set out in Schedules 2 and 3 of this Order.
4. Save as provided in Articles 7 and 9 of this Order no person except on the direction of a Police Constable in uniform or of a Parking Attendant shall cause or permit any vehicle to wait, load or unload at any time on the lengths of sides of roads as set out in Schedule 2 of this Order.
5. Save as provided in Articles 6, 7, 8 and 9 of this Order no person except on the direction of a Police Constable in uniform or of a Parking Attendant shall cause or permit any vehicle to wait at any time on the lengths of sides of road as set out in Schedule 3 of this Order.
6. Nothing in Article 5 of this Order shall render it unlawful to cause or permit a Disabled Person's Vehicle which displays in the relevant position a Disabled Person's Badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the lengths of sides of roads referred to in the Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same length of side of road on which that vehicle had previously been waiting).
7. Nothing in Articles 4 and 5 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable: -
  - (A) A person to board or alight from a vehicle;
  - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
    - (i) Building, industrial or demolition operations;
    - (ii) The removal of any obstruction to traffic;
    - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;

- (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
  - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
  - (E) Public Services Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
  - (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
8. Nothing in Article 5 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable goods to be loaded and unloaded from the vehicle.
9. The prohibitions imposed by Articles 4 and 5 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

## SCHEDULES

### Schedule 1 – Revocation

West Glamorgan County Council (Water Street, Port Talbot) (Prohibition of Waiting) Order 1985.

Schedule

(iii) Green Park Street (both sides)

Between its junction with Afan Way and a point 20 metres south east of that junction.

(v) Water Street/Green Park Street Link Road (both sides)

Between its junction with Water Street and a point 18 metres south east of that junction.

Neath Port Talbot County Borough Council (Green Park Street, Water Street/Afan Way, Port Talbot) (No Waiting, Loading or Unloading At Any Time) (Prohibition of Right Turn) (No Waiting At Any Time) and (Limited Waiting) Order 2000.

Schedule 1 – No Waiting, Loading or Unloading At Any Time

1. Green Park Street (north east side)

(i) From its westerly junction with Water Street (Afan Way) to a point approximately 12 metres south east of that junction.

(ii) Between points approximately 23 metres and 67 metres south east of its junction with Water Street (Afan Way).

(South West Side)

From its junction with Water Street (Afan Way) to a point approximately 90 metres south east of that junction.

Schedule 3 – No Waiting At Any Time

1. Green Park Street (north east side)

Between points approximately 67 metres and 85 metres south east of its junction with Water Street (Afan Way)

Schedule 4 – Waiting Limited to 1 hour, no return within 2 hours Monday-Saturday  
8am to 6pm

1. Green Park Street (north east side)

Between points approximately 12 metres and 23 metres south east of its junction with Water Street (Afan Way).

**Schedule 2 – Prohibition of Waiting, Loading and Unloading at any Time**

**2.1 Green Park Street (north east side)**

From its junction with Afan Way for a distance of approximately 65 metres in a south easterly direction.

**2.2 Green Park Street (south west side)**

From its junction with Afan Way for a distance of approximately 33 metres in a south easterly direction.

**2.3 Green Park Street (south side)**

Between points approximately 43 metres and 92 metres in a south easterly then north easterly direction from its junction with Afan Way.

**2.4 Afan Way (south east side)**

From the south western kerblines of its junction with Green Park Street for a distance of approximately 15 metres in a south westerly direction.

**2.5 Afan Way/Water Street (south east side)**

From the north eastern kerblines of its junction with Green Park Street for a distance of approximately 142 metres in a north easterly direction.

**2.6 Water Street (south east side)**

From the north eastern kerblines of its junction with Green Park Street Link Road for a distance of approximately 15 metres in a north easterly direction.

**2.7 Green Park Street Link Road (both sides)**

From its junction with Water Street for a distance of approximately 24 metres in a south easterly direction.

**Schedule 3 – Prohibition of Waiting At Any Time**

**3.1 Green Park Street (north west side)**

Between points approximately 90 metres and 100 metres in a south westerly direction from its junction with Green Park Street Link Road.

**3.2 Green Park Street (north west side)**

Between points approximately 70 metres and 80 metres in a south westerly direction from its junction with Green Park Street Link Road.

**3.3 Green Park Street (north west side)**

From the south western kerblines of its junction with Green Park Street Link Road for a distance of approximately 20 metres in a south westerly direction.

**3.4 Green Park Street (north west side)**

From the north eastern kerbline of its junction with Green Park Street Link Road for a distance of approximately 10 metres in a north easterly direction.

**3.5 Green Park Street Link Road (south west side)**

Between points approximately 35 metres and 42 metres in a north westerly direction from its junction with Green Park Street.

**3.6 Green Park Street Link Road (both sides)**

From its junction with Green Park Street for a distance of approximately 10 metres in a north westerly direction.

**3.7 Road A (both sides)**

From its junction with Green Park Street for a distance of approximately 10 metres in a north westerly direction.
