ORDER 2013

The Neath Port Talbot County Borough Council in exercise of its powers under Sections 1, 2, 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984) and of all other powers then enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order: -

1. This Order shall come into operation on the 16th day of August 2013 and may be cited as the "Neath Port Talbot County Borough Council (Heathfield Avenue, Glynneath) (Goods Vehicles Loading Only, 8.00am to 6.00pm) Order 2013".
2. (1) In this Order –

"Public Service Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;

"Loading Bay" means a parking place designated by this Order as a parking place only for the use of goods vehicles which are being loaded or unloaded;

"Universal Service Providers" means those operators of a postal service who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.

(2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

(3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The provisions of any existing Loading Only or Prohibition of Waiting, Loading or Unloading Orders (if any) are hereby revoked in so far as they relate to the lengths and sides of road set out in the Schedule to this Order.
- 4 (1) The Loading Bay as set out in the Schedule of this Order is designated as a parking place between the hours of 8.00am and 6.00pm for goods vehicles which are being loaded or unloaded only.

- (2) Save as provided by Articles 5 and 6 of this Order no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle (including a Disabled Persons Vehicle) to use the Loading Bay referred to in Article 4(1) above other than for the purpose of loading or unloading goods vehicles.

5. Nothing in Article 4(1) of this Order shall render it unlawful to cause or permit any vehicle to wait on the Loading Bay or lengths of sides of roads specified therein for so long as may be necessary to enable: -
- (A) A person to board or alight from a vehicle;
 - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely: -
 - (i) Building, industrial or demolition operations;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road or any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in the Telecommunications Act 1984;
 - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
 - (E) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
 - (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
6. The prohibitions imposed by Article 4(1) of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service Vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

Goods Vehicles Loading Only, 8.00am to 6.00pm Heathfield Avenue, Glynneath (West Side)

From a point approximately 15 metres north west of its junction with High Street for a distance of approximately 20 metres in a north westerly direction.
