ORDER 1998

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1, 2, 32, 35, 45, 46, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following order:-

1. This Order shall come into operation on the 26th day of October 1998 and may be cited as the Neath Port Talbot County Borough Council (Henfaes Road, Tonna - High Street, Skewen - Various Streets, Neath) (Residents Parking) Order 1998

2. (1) In this Order -

"Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986;

"Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by The Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991;

"Parking Disc" means a disc issued by a Local Authority, complying with the requirements of the British Standard Specification for Parking Discs (B.S. 4631 - 1970) coloured orange and capable of showing the quarter hour period during which a period of waiting begins;

"Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1991;

"Public Service Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local Service" shall have the same meaning as in Section 1 of the Transport Act 1985;

"Carriageway" means a way consisting of or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

"Residents Parking Place" (hereinafter referred to as a "Parking Place") means an area of highway designated as a Parking Place by this Order for the use of vehicles displaying on the front or nearside of the vehicle a valid Residents Parking Place Permit;

"Residents Parking Place Permit" (hereinafter referred to as "a Residents Permit") means a Permit issued by the Council for a period of up to twelve months to a person who has satisfied the Council as being entitled to the issue of a Residents Permit in accordance with the Council's policy as may be determined from time to time;

Each area on a highway referred to in Schedule 2 to this Order and bounded on one side by the edge of the carriageway and on the other side by a broken white line is designated as a Parking Place.

- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The provisions of the Orders specified in Schedule 1 to this Order are hereby revoked insofar as they relate to the sides and lengths of roads specified in Schedule 2 to this Order.
4. **Residents Parking Places**  

Except as provided by Articles 5, 7 and 8 of this Order or upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden no person shall cause or permit any vehicle to wait in a Parking Place designated by Schedule 2 to this Order.
5. The provisions of Article 4 to this Order shall not apply to the holder of a Residents Permit when parking a vehicle in a Parking Place as described in Schedule 2 to this Order and the vehicle is displaying a valid parking permit (on the front or nearside of the vehicle).
6. **Regulation of Parking Place**
  - A. (i) The holder of a Residents Permit shall not park in any Parking Place other than in the street named on the Permit;
  - (ii) where a Police Constable in uniform or a Traffic Warden is of the opinion that the provisions contained in Article 4 of this Order have been contravened he may remove or cause to be removed the vehicle from the Parking Place and where it is so removed shall provide for the safe custody of the vehicle;
  - (iii) a Police Constable in uniform or a Traffic Warden may move or cause to be moved in the case of emergency to any place he thinks fit any vehicle left in the Parking Place;
  - (iv) the Permit shall be valid only for the vehicle in respect of which it is issued and no permit holder shall cause or permit any Permit issued to him by the Council to be displayed on any vehicle bearing a different registration number to that contained on that Permit;
  - (v) every vehicle left in the Parking Place shall stop so that every part of the vehicle is within the limits of the Parking Place.

B. A Police Constable in uniform or a Traffic Warden or a person duly authorised by the Council may suspend the use of the Parking Place or any part thereof whenever he considers such suspension is reasonably necessary:-

- (i) for the purposes of facilitating the movement of traffic or promoting its safety;
- (ii) for the purposes of any building operation, the maintenance, improvement or reconstruction of the highway, or the cleansing of gullies in or adjacent to the Parking Place, the laying, erection, alteration or repair in or adjacent to the Parking Place of any sewer or of any main pipe or apparatus for the supply of gas, water, or electricity or of any telegraphic line or the placing maintenance or removal of any traffic sign;
- (iii) for the convenience of occupiers of premises adjacent to the Parking Place on any occasion of the delivery or removal of furniture to or from any office or dwelling house adjacent to the Parking Place;
- (iv) on any occasion on which it is likely by reason of some special attraction that any streets will be thronged or obstructed;
- (v) for the convenience of occupiers of premises adjacent to the Parking Place at times of weddings or funerals;
- (vi) any person or Police Constable in uniform or a Traffic Warden suspending the use of the Parking Place or any part thereof, in accordance with the provisions of this Article shall thereupon place or cause to be placed in that Parking Place or as the case may be that part thereof the use of which is suspended a traffic sign of any size, colour and type prescribed or authorised under Section 64 of the Act of 1984 indicating that the waiting by vehicles is prohibited.

C. No person shall cause or permit any vehicle to wait in any part of the Parking Place during such period as there is in or adjacent to that part of the Parking Place a traffic sign placed in pursuance of Article 6B(vi) of this Order.

Provided that nothing in this Article shall apply:-

- (i) in respect of any vehicle being used for fire brigade, ambulance or police purposes or any vehicle which is waiting for any other reason specified in this Order;
- (ii) to anything done with the permission of a Police Constable in uniform, Traffic Warden or the person suspending the use of the Parking Place or part thereof in pursuance of this Order.

- D. (i) Nothing in Article 4 of this Order shall apply to:-
- (a) legally qualified medical practitioners as defined in Section 52 of the Medical Act 1956, community nurses or registered veterinary surgeons while visiting premises adjacent to the Residents Parking Place provided that the vehicle is displaying an appropriate worded notice to the effect that it is being used "on call";
  - (b) a maximum of two vehicles being used in connection with a wedding;
  - (c) vehicles being used for building and maintenance purposes in properties adjacent to a Parking Place;
  - (d) to enable any hearse or any vehicle owned by a funeral director or owner of funeral vehicles to be used as part of a funeral cortege or otherwise in connection with a funeral;
  - (e) to enable Support Officers of a bona fide care organisation to park in the Residents Only Parking Area whilst visiting a Community Care dwelling in pursuit of their duties, providing the special permit issued by the Council is displayed in the correct position on the front windscreen of their vehicle.

#### Permits

- E. (i) The Council may at any time require an applicant for a Permit or the holder of a Permit to produce to an Officer of the Council such evidence in respect of an application for a Permit made to them as they may reasonably require to verify any particulars or information given to them or in respect of any Permit issued by them as they may reasonably require to verify that the Permit is valid;
- (ii) On receipt of an application for a Permit the Council upon being satisfied that:-
- (a) the applicant is a person who resides in a road referred to in Schedule 2 to this Order or is a person who falls within the categories of persons eligible for the granting of a Permit as may be determined from time to time by the Council;
  - (b) the application is made in respect of an eligible vehicle as defined in paragraph (iii) of this Article;
- shall issue to the applicant a Permit in respect of that vehicle, subject to no more than two Permits being issued in respect of any particular residence.

- (iii) For the purposes of this Article "eligible vehicle" means:-
  - (a) a passenger vehicle which is a motor vehicle constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the driver and not drawing a trailer;
  - (b) solo motor cycle or moped.
- (iv)
  - (a) No person shall be entitled to hold a Permit for more than one vehicle at any one time;
  - (b) The Permit shall be valid only for the vehicle in respect of which it is issued and no permit holder shall cause or permit any Permit issued to him by the Council to be displayed on any vehicle bearing a different registration number to that contained on that Permit.
- (v) A permit holder may surrender a Permit to the Council at any time and shall surrender it to the Council on the occurrence of any one of the following events:-
  - (a) the permit holder ceasing to be a resident in the street for which the Permit was issued;
  - (b) save as provided in paragraph (viii)(a) of this Article the permit holder ceasing to be the owner of the vehicle in respect of which the Permit was issued;
  - (c) the vehicle in respect of which the Permit was issued being adapted or used in such a manner that it ceases to be an eligible vehicle as defined in paragraph (iii) of this Article;
  - (d) the issue by the Council of a duplicate Permit;
  - (e) the expiry of the Permit pursuant to paragraph (vi) of this Article;
  - (f) the withdrawal of the Permit by the Council.
- (vi) A Permit shall cease to be valid at the expiration of the date stated thereon or on the occurrence of any of the events set out in paragraph (v) of this Article whichever is the earlier.
- (vii) The Council may by notice in writing served on a permit holder by sending the same by recorded delivery service to the permit holder at the address shown by that person on the application for the Permit or at any other address believed to be that person's abode withdraw a Permit if it appears to the Council that any of the events set out in paragraph (v) of this Article has occurred and the Permit Holder shall surrender the Permit to the Council within forty eight hours of the receipt of the aforementioned notice.

- (viii) A Permit shall be in writing and shall include the following particulars:-
- (a) the registration mark of the vehicle in respect of which the Permit was issued except when such Permit is issued to a resident whose vehicle is owned by a bona fide motor trader and in such cases the registration mark will be replaced with the words "MOTOR TRADER";
  - (b) the expiry date of the Permit pursuant to paragraph (vi) of this Article;
  - (c) an indication that the Permit was issued by the Council;
  - (d) the name of the street in which the applicant resides.

### **Charges**

- F. (i) The issue of a residents permit, shall be subject to the successful applicant for a permit paying a charge of £10.00 to the Council for the issue and use of the permit, such payment to be paid to the Council prior to the issue of the permit.
- (ii) In the event that a permit holder requires a duplicate permit to replace a permit which has been lost or destroyed, the issue of such a permit shall be subject to a fee of £5.00 being paid to the Council prior to the issue of the duplicate permit.

7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides and lengths of roads specified therein for as long as may be necessary to enable:-
- (a) a person to board or alight from the vehicle;
  - (b) goods to be loaded on or unloaded from the vehicle;
  - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstruction of traffic;
    - (iii) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in the Telecommunications Act 1984;
    - (iv) a vehicle being used for Police, Ambulance or Fire Brigade purposes; or

- (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
  - (e) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 37 of the Post Office Act, 1953;
  - (f) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road;
  - (g) public service vehicles when waiting at an authorised bus stop to set down or pick up passengers.
8. The prohibitions imposed by Article 4 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

### SCHEDULE 2 - RESIDENTS PARKING FOR PERMIT HOLDERS

1. **Henfaes Road, Tonna (North West Side).**
  - (1) Between points approximately 1 metre North East and 11 metres North West of a point in line with the South East kerblines of Quarry Road.
  - (2) Between points approximately 31 metres South West and 75 metres South West of a point in line with the South West kerblines of School Road.
  - (3) Between points approximately 11 metres South West and 7 metres North East of a point in line with South West kerblines of School Road.

**2. High Street, Skewen (West Side)**

- (1) Between points 16 metres and 38 metres North of it's junction with Old Road.
- (2) Between points 63 metres and 89 metres North of it's junction with Old Road.
- (3) Between points 154 metres and 202 metres North of it's junction with Old Road.

**3. Rosser Street, Neath (South Side)**

- (1) Between points 35 metres and 59 metres (approximately) North West from the north western kerbline of Gnoll Park Road.
- (2) Between points 80 metres and 104 metres (approximately) North West from the north western kerbline of Gnoll Park Road.

**4. Hibbert Road, Neath (South Side)**

Between points 60 metres and 84 metres (approximately) north west from the north western kerbline of Gnoll Park Road.

**5. Hibbert Road, Neath (North Side)**

Between points 97 metres and 122 metres (approximately) north west from the north western kerbline of Gnoll Park Road.

**6. Park Street, Neath (South Side)**

Between points 57 metres and 75 metres (approximately) north west from the north western kerbline of Gnoll Park Road.

**7. Park Street, Neath (North Side)**

Between points 77 metres and 95 metres (approximately) north west from the north western kerbline of Gnoll Park Road.

**8. Leonard Street, Neath (South Side)**

- (1) Between points 40 metres and 70 metres (approximately) east of the eastern kerbline of Gnoll Park Road.
- (2) Between points 140 metres and 158 metres (approximately) east of the eastern kerbline of Gnoll Park Road.

**9. Leonard Street, Neath (North Side)**

Between points 90 metres and 114 metres (approximately) east of the eastern kerbline of Gnoll Park Road.



10. Harle Street, Neath (North Side)

- (1) Between points 55 metres and 85 metres (approximately) east of the eastern kerbline of Gnoll Park Road.
- (2) Between points 125 metres and 143 metres (approximately) east of the eastern kerbline of Gnoll Park Road.

11. Harle Street, Neath (South Side)

Between points 5 metres and 23 metres (approximately) east of the eastern kerbline of Hazelwood Road.

12. Gnoll Park Road, Neath (West Side)

- (1) Between points 10 metres and 28 metres (approximately) north of the northern kerbline of Rosser Street.
- (2) Between points 10 metres and 28 metres (approximately) south of the southern kerbline of Hibbert Road.
- (3) Between points 10 metres and 28 metres (approximately) north of the northern kerbline of Hibbert Road.
- (4) Between points 10 metres and 28 metres (approximately) south of the southern kerbline of Park Street.
- (5) Between points 10 metres and 34 metres (approximately) north of the northern kerbline of Park Street.
- (6) Between points 30 metres and 54 metres (approximately) south of the southern kerbline of Pen-y-Dre.
