ORDER 1992

The West Glamorgan County Council in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

1. This Order shall come into operation on the 14th day of December 1992 and may be cited as the "West Glamorgan County Council (Jersey Marine Village) (Weight Restriction) (Except for Access) (Width Restriction) and (Traffic Priority in One Direction) Order 1992.
2. Save as provided in Article 3 to this Order or on the direction of a Police Constable in uniform, no person shall cause any vehicle over 7,5 tonnes maximum gross weight to proceed along the lengths of road as shown in Schedule 1 to this Order.
3. Nothing in Article 2 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in the lengths of road referred to in Schedule 1 for the conveyance of persons, goods or merchandise to or from premises situated on or adjacent thereto or deriving access solely therefrom.
4. No person shall cause or permit any vehicle, the width of which, including any load on the vehicle, exceeds 4.5 metres to proceed along the lengths of road shown in Schedule 2 of this Order.
5. Save as provided in Article 6 of this Order, no person shall cause or permit any vehicle proceeding in that direction in the lengths of road specified in Schedule 3 to this Order if there is a vehicle proceeding or waiting to proceed in the opposite direction in those lengths of road specified.
6. Nothing in Article 5 of this Order shall apply to a vehicle being used for Police, Fire Brigade or Ambulance purposes.
7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE 1

**WEIGHT RESTRICTION (7.5 TONNES) (EXCEPT FOR ACCESS)
JERSEY MARINE VILLAGE ALL ROADS WITHIN THE VILLAGE OF
JERSEY MARINE**

Between a point on the B4290, 490 metres approximately north-west of its junction with Fabian Way (A483).

Between a point on the B4290, 160 metres approximately north-east of its junction with Pant-y-Sais.

SCHEDULE 2

WIDTH RESTRICTION (4.5 METRES)

At a point on the B4290, 490 metres approximately north-west of its junction with Fabian Way (483) and at a point on the B4290, 160 metres approximately north-east of its junction with Pant-y-Sais, the carriageway will be restricted in width to 4.5 metres to control entry for single file traffic.

SCHEDULE 3

TRAFFIC PRIORITY IN ONE DIRECTION

Southbound flow (leaving the Village) will have priority movement over the opposing traffic, northbound flow (entering the Village) at a point on the B4290, 490 metres approximately north-west of its junction with Fabian Way (A483).

Northbound flow (leaving the Village) will have priority movement over the opposing traffic, southbound flow (entering the Village) at a point on the B4290, 160 metres approximately north-east of its junction with Pant-y-Sais.
