

WEST GLAMORGAN COUNTY COUNCIL

(LIMITED WAITING AREAS) (RESIDENTS' PARKING AREAS)

(No. 1) ORDER 1991

The West Glamorgan County Council in exercise of its powers as contained in Sections 1, 2, 32, 36 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultaion with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

- 1. This Order may be cited as the West Glamorgan County Council (Limited Waiting Areas) (Residents' Parking Areas) (No.1) Order 1991 and shall come into operation on the 26 day of July 1991.
- 2. The provisions of the following Orders shall be varied by the addition thereto of the provisions of Articles 3 and 4 of this Order:-

West Glamorgan County Council (Various Roads, Gorseinon and Loughor) (One Way Traffic) (3 Ton Weight Restriction) (Prohibition of Waiting, Loading and Unloading) (Limited Waiting) and (Revocation) Order 1974 made by the West Glamorgan County Council operative from 10th September 1979

The West Glamorgan County Council (Various Streets, Neath) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1976 made by the West Glamorgan County Council on 17th March 1976

West Glamorgan County Council (Neath Town Centre) (Traffic Management) Order 1988 made by the West Glamorgan County Council on 5th December 1988

The City of Swansea (George Street, Henrietta Street, Nicholl Street, Russell Street, Page Street, Duke Street, Brunswick Street, St. Helen's Road, Walter Road)(Restriction of Waiting) Order 1971 made by the Council of the City of Swansea and operative from 11th October, 1971.

- 3. The provisions of the several Orders as set out in Article 2 to this Order shall not apply so as to prevent any resident from parking a car on any day on the sides or lengths of street as set out in the Schedule to this Order when displaying in the windscreen of their car a Residents' Parking Place Permit.
- 4. The provisions of Articles 1, 4, 5, 6, 7, 8, 9 of the County of West Glamorgan (Residents Parking Places) Order 1990 shall apply to this Order
- 5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE

Amendment to Existing Limited Waiting Orders, To Accommodate Residents Parking

Page Street, Swansea West Street

- a) From points 10m and 40m (approx), and 48m and 57m (approx), north of its junction with St. Helen's Road.
- b) From points 20m and 35m (approx), and 53m and 80m (approx) south of its junction with Mansel Street/Walter Road.

East Side

From points 20m and 52m (approx), 67m and 80m (approx), and 95m and 115m (approx) south of its junction with Mansel Street/Walter Road.

The Ropewalk, Neath

South Side

- a) From a point 10m and 45m (approx), west of its junction with London Road.
- b) From a point 10m and 62m (approx), west of its junction with Rectory Road.
- c) From a point 10m and 25m (approx), east of its junction with Windsor road.

Ena Avenue, Neath

East Side

From a point 10m (approx) from its junction of Cimla Road northwards, to a point 10m (approx) from its junction with Gnoll Avenue.

West Side

- a) From a point 10m (approx), from its junction with Cimla Road, northwards to a point 10m (approx) from its junction with Glyn-y-Coed Road.
- b) From a point 10m (approx), from its junction with Glyn-y-Coed Road, northwards to a point 10m (approx), from its junction with Gnoll Avenue.

Creswell Road, Neath

Centre of Carriageway

From a point 29m and 104m (approx) west of its junction with Victoria Gardens.

Lime Street, Gorseinon

North Side

From a point 20 metres west of the west side of Cross Street westwards a distance of approximately 100 metres. From a point 10 metres east of the east side of Cross Street eastwards a distance of approximately 26 metres. From a point 57 metres east of the east side of Cross Street eastwards a distance of approximately 13 metres. From a point 85 metres east of the east side of Cross Street eastwards a distance of approximately 20 metres. From a point 10 metres west of the west side of Trinity Street westwards a distance of approximately 17 metres. From a point 37 metres west of the west side of Trinity Street westwards a distance of approximately 9 metres.

Trinity Street, Gorseinon

West Side

From a point 10 metres south of the south side of Lime Street southwards a distance of approximately 47 metres. From a point 79 metres south of the south side of Lime Street southwards a distance of approximately 44 metres.

East Side

From a point 5 metres north of the north side of Lime Street northwards a distance of approximately 56 metres.

Nicholl Street, Swansea

East Side

- a) Between points 10m and 40m (approx) north of its junction with St. Helen's Road.
- b) Between points 10m and 28m (approx) north of its junction with the rear lane of St. Helen's Road.
- c) Between points 40m and 75m (approx) north of its junction with the rear lane of St. Helen's Road.

West Side

- a) Between points 15m and 50m (approx) north of its junction with St. Helen's Road.
- b) Between points 15m and 25m (approx) south of its junction with Walter Road.
- c) Between points 30m and 36m (approx) south of its junction with Walter Road.

George Street, Swansea

West Side

- a) Between points 15m and 55m (approx) north of its junction with St. Helen's Road.
- b) Between points 15m and 30m (approx) south of its junction with Walter Road.

East Side

- a) Between points 10m and 33m (approx) south of its junction with Walter Road.
- b) Between points 5m and 27m (approx) south of its junction with the rear lane of Walter Road.
- c) Between points 35m and 70m (approx) south of its junction with the rear land of Walter Road.
- d) Between points 5m and 30m (approx) north of its junction with the rear lane of St. Helen's Road.
