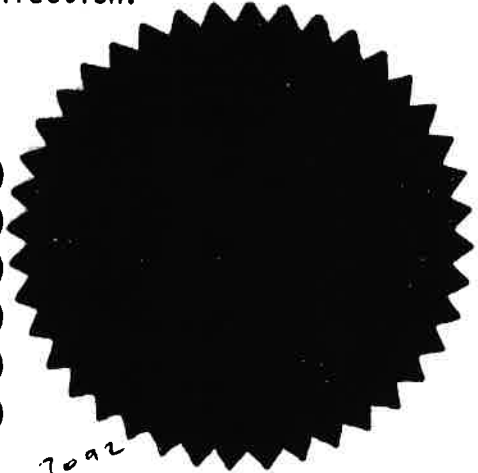
(PROHIBITION OF ENTRY RIGHT HAND TURN AND

ONE WAY) ORDER 1981

The Council of the County of West Glamorgan in exercise of their powers under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 (which said Act of 1967 as amended is hereinafter called the "Act of 1967") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Section 84 (C) of the Act of 1967, hereby make the following Order :

1. This Order shall come into operation on *29th March 1982* and may be cited as the "West Glamorgan County Council (Lon Cadog, Broadway, Glanmor Road and Sketty Avenue, Swansea) (Prohibition of Entry Right Hand Turn and One Way) Order 1981.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
3. No person shall cause any vehicle to turn right into Cockett Road (A.4216) from Lon Cadog.
4. No person shall cause any vehicle to turn right into Glanmor Road and Sketty Avenue from Broadway.
5. No person shall cause any vehicle to proceed in that length of Sketty Avenue from its junction with the southern kerbline of Glanmor Road in a southward direction to its junction with the northern kerbline of Hazelmere Road for a distance of 60 metres (66 yards) or thereabouts other than in a southerly direction.

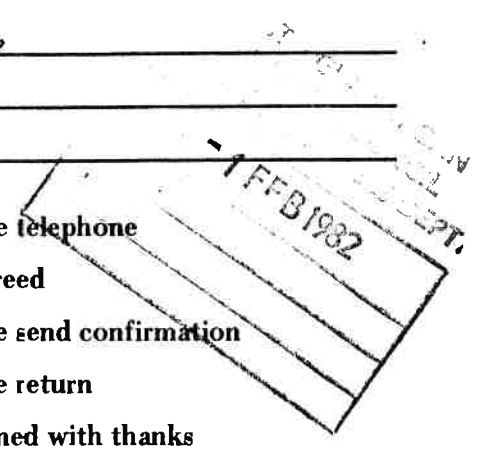
