(MAIN ROAD, BRYNCOCH, NEATH)
(PROHIBITION OF WAITING AT ANY TIME)

ORDER 2009

The Neath Port Talbot County Borough Council in exercise of its powers as contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order: -

1. This Order shall come into operation on the 9th day of February 2009 and may be cited as the "Neath Port Talbot County Borough Council (Main Road, Bryncoch, Neath) (Prohibition of Waiting at Any Time) Order 2009".

2. (1) In this Order –

"Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;

"Disabled Person's Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

"Parking Disc" means a parking disc issued by a Local Authority capable of showing the quarter hour period on which a period of waiting begins;

"Relevant Position" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

"Public Service Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1982 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;

"Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provision contained in the Postal Services Act 2000;

- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

3. Save as provided in Articles 4, 5 and 6 of this Order no person except at the direction of a Police Constable in uniform or of a Parking Attendant shall cause or permit any vehicle to wait at any time on the lengths of sides of road as set out in the Schedule to this Order.
4. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a Disabled Person's Vehicle which displays in the relevant position a Disabled Person's Badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the lengths of sides of roads referred to in the Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same length of side of road on which that vehicle had previously been waiting).
5. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable:-
 - (A) A Person to board or alight from a vehicle;
 - (B) Goods to be loaded or unloaded from a vehicle;
 - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely;
 - (i) Building, industrial or demolition operations;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of roads of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
 - (D) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (E) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
 - (F) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses.
 - (G) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.

6. The prohibitions imposed by Article 3 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Services or to Local Authority vehicles when in pursuance of statutory duties or powers.

SCHEDULE

Prohibition of Waiting At Any Time

Main Road, Bryncoch (West Side)

From its junction with Neath Road for a distance of approximately 180 metres in a southerly direction.

Main Road, Bryncoch (East Side)

1. From its junction with Neath Road for a distance of approximately 175 metres in a southerly direction.
2. From a point approximately 38 metres north of its northern kerbline of Furzeland Drive for a distance of approximately 12 metres in a northerly direction.
3. From a point approximately 16 metres north of the northern kerbline of Furzeland Drive for a distance of approximately 238 metres in a southerly direction.

Furzeland Drive (North Side)

From its junction with Main Road for a distance of approximately 15 metres in an easterly direction.
