WEST GLAMORGAN COUNTY COUNCIL

(MARGAM STREET, CYMER)

(REVOCATION) AND (LIMITED WAITING) ORDER 1985

The Council of the County of West Glamorgan (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 3 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with the provision of Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

- 1. This Order shall come into operation on the 9th day of December 1985 and may be cited as the West Glamorgan County Council (Margam Street, Cymer) (Revocation) and (Limited Waiting) Order 1985.
- 2. (1) In this Order:-

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1975;

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975;

"Parking disc" means a disc issued by a Local Authority, complying with the requirements of the British Standard Specification for Parking Discs (BS. No. 6431: 1970), coloured orange, and capable of showing the quarter hour period during which a period of waiting begins; and

- (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (a) a disabled person's badge in the relevant position, when:-
 - (i) in the case of a vehicle fitted with a front windscreen the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen;
 - (ii) in the case of a vehicle not fitted with a front windscreen the badge is exhibited in a conspicuous position on the front or nearside of the vehicle.
 - (b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side window nearest to the kerb.

- (3) The Interpretation Act, 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Save as provided in Article 4 of this Order no person shall, except upon the direction of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait, for any period longer than 30 minutes return prohibited within one hour on any day except Saturday and Sunday between the hours of 8.00 a.m. and 6.00 p.m. on the length or side road specified in the Schedule to this Order
- 4. (1) Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of road specified therein for so long as may be necessary to enable:-
 - (i) a person to board or alight from the vehicle;
 - (ii) goods to be loaded or unloaded from the vehicle;
 - (iii) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (a) building, industrial or demolition operations;
 - (b) the removal of any obstruction to traffic;
 - (c) the maintenance, improvement or reconstruction of the side of road; or
 - (d) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878.
 - (iv) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - (v) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
 - (vi) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of road or side of road;

- (vii) the vehicle to wait at or near to any premises situated on or adjacent to the said side or any of the said lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral; or
- (viii) the vehicle to be used for police, fire brigade or ambulance purposes.
- Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the side of road referred to in those Articles for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length or on the same side of road on the same day).
- The provisions of the West Glamorgan County Council (Margam Street, Cymmer) (Prohibition of Waiting) Order 1976 are hereby revoked in so far as it affects the sides or lengths of roads as set out in the Schedule to this Order.
- 6. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
