# NEATH PORT TALBOT COUNTY BOROUGH COUNCIL

(FORSTER ROAD, NEATH)

## (PROHIBITION OF WAITING) AND (REVOCATION)

**ORDER 1997** 

The Neath Port Talbot County Borough Council (successor to West Glamorgan County Council) in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984" and of all other powers them enabling and after consideration with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the

This Order shall come into operation on the 24th day of February 1997 and may be cited as the "Neath Port Talbot County Borough Counell (For Road, Neath) (Prohibition of Waiting) and (Revocation) Order 1997".

#### 2. In this Order:-

"disabled person's badge" has the same meaning as in The Local Authorities' Traffic Order (Exemptions for Disabled Persons) (England and Wales)

"disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by the Disabled persons (Badges for Motor Vehicles) (Amendment) Regulations 1991.

"parking disc" means a disc issued by a Local Authority, complying with the requirements of the British Standard Specification for Parking Discs (B.S. 4631 - 1970) coloured crange, and capable of showing the quarter hour period during which a period of waiting begins, and

"relevant position" has the same meaning as in The Disabled Persons (Badges for Motor Veh cles) Regulations 1982 as amended by the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales)

- The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
- The provision of the Orders as specified in Schedule 1 to this order are hereby revoked insofar as they relate to the sides or lengths of road set out in the subsequent schedules. 5.
- Save as provided in Articles 6 or 7 of this Order no person shall, except upon the direction of the Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the sides or lengths of roads 6.
- Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides or lengths of roads specified therein for so

- (a) a person to board or alight from a vehicle;
- (b) goods to be loaded on or unloaded from the vehicle;
- (c) the vehicle if it cannot conveniently be used for such purpose ion any operations, namely:-
  - (i) building, industrial or demolition operations;
  - the laying, erection, alteration or repair in or on land adjacent to the said side of road of any service communications apparatus defined at the communications Apr. 1984 or

other road, to be used in the service of a Local Authority or of a water authority in pursuance of statutory powers and duties:

- (e) the vehicle to be used for the purpose of delivering or collecting postel packets as defined in Section 87 of the Post Office Act 1953;
- (f) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road;
  - (g) public service vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers.
- 7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled in tharge of the vehicle, has marked the time of which the period of waiting not exceeding 3 hours (not being a period separated by an interval of less same side of road).
  - 8. The prohibition and restrictions imposed by this Order shall be in addition to and not in decognition of any other prohibition or restriction whether made up her the Act of 1984 or atherwise.
