NEATH PORT TALBOT COUNTY BOROUGH COUNCIL
(FORSTER ROAD, NEATH)

(PROHIBITION OF WAITING)
AND (REVOCATION)

ORDER 1997

The Neath Port Talbot County Borough Council (successor to West Glamorgan County Council) in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984" and of all other powers them enabling and after consideration with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order

1. This Order shall come into operation on the 24th day of February 1997 and may be cited as the "Neath Port Talbot County Borough Council (Forster Road, Neath) (Prohibition of Waiting) and (Revocation) Order 1997".
2. In this Order:-
 - "disabled person's badge" has the same meaning as in The Local Authorities' Traffic Order (Exemptions for Disabled Persons) (England and Wales) Regulations 1986.
 - "disabled person's badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by the Disabled persons (Badges for Motor Vehicles) (Amendment) Regulations 1991.
 - "parking disc" means a disc issued by a Local Authority, complying with the requirements of the British Standard Specification for Parking Discs (B.S. 4631 - 1970) (coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, and
 - "relevant position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1991.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. The provision of the Orders as specified in Schedule 1 to this order are hereby revoked insofar as they relate to the sides or lengths of road set out in the subsequent schedules.
5. Save as provided in Articles 6 or 7 of this Order no person shall, except upon the direction of the Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the sides or lengths of roads specified in Schedule 3 to this Order.
6. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides or lengths of roads specified therein for so long as may be necessary to enable:-

- (a) a person to board or alight from a vehicle;
- (b) goods to be loaded on or unloaded from the vehicle;
- (c) the vehicle if it cannot conveniently be used for such purpose on any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in the Telecommunications Act 1984 or
- (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or of a water authority in pursuance of statutory powers and duties;
- (e) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
- (f) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road;
- (g) public service vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers.

7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or the other person in charge of the vehicle, has marked the time of which the period of waiting began) to wait on the side of road referred to in the said Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of road).

8. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise.

SCHEDULES

SCHEDULE 1 REVOCATIONS

The provisions of the Orders as set out in the Schedule are hereby revoked insofar as they relate to the sides or lengths of road set out in the subsequent Schedules:-

- a) West Glamorgan County Council (Woodland Road and Forster Road, Neath) (One Way Traffic) Order 1993.
- b) West Glamorgan County Council (various Streets, Neath) (Prohibition and Restriction of Waiting, Loading and Unloading) (Amendment No.3) Order 1977.

**SCHEDULE 2
REVOCATION OF ONE WAY ORDER
FORSTER ROAD**

From its junction with Woodland Road to its junction with Gnoll Park Road.

**SCHEDULE 3
TO INTRODUCE PROHIBITION OF WAITING AT ANY TIME
FORSTER ROAD (NORTH SIDE)**

From a point 10 metres from its junction with Gnoll Park Road for a distance of 55 metre in an easterly direction.

Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc to stop at a bus stop.
