1.1 Any existing Orders are hereby revoked only in so far as they relate to the sides and lengths of roads set out in the Schedules of this Order.

ORDER 2020

The Neath Port Talbot County Borough Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

- 1. This Order shall come into operation on the 17th day of August 2020 and may be cited as the "Neath Port Talbot County Borough Council (Twywn Primary School and Coed Ffranc Junior School) (Revocation) (No Stopping on School Entrance Markings, Monday to Friday 8am to 5pm) and (Prohibition of Waiting, Loading or Unloading at any time) Order 2020".
- 2. (1) In this Order
 - "Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;
 - "Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.
 - (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
- 3. The provisions of any existing no stopping on school entrance marking orders and/or prohibition of waiting, loading or unloading at any time orders (if any) are hereby revoked insofar as they relate to the sides and lengths of roads set out in the Schedules to this Order.
- 4. Save as provided in Articles 6 and 8 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to stop between the hours of 8.00am and 5.00pm Monday to Friday on the lengths of sides of roads set out in Schedule 1 of this Order.
- Save as provided in Articles 7 and 8 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload between the hours of 8.00am and 5.00pm Monday to Friday on the length of side of road set out in Schedule 2 of this Order.

- 6. Nothing in Article 4 shall render it unlawful to cause or permit any vehicle to wait on the lengths of roads specified therein for so long as may be necessary to enable: -
 - (A) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
 - (i) Building, industrial or demolition operations;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
 - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (C) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
 - (D) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
 - (E) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
- 7. Nothing in Article 5 shall render it unlawful to cause or permit any vehicle to wait on the lengths of roads specified therein for so long as may be necessary to enable: -
 - (A) A person to board or alight from a vehicle;
 - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
 - (i) Building, industrial or demolition operations;
 - (iv) The removal of any obstruction to traffic;
 - (v) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
 - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (F) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;

- (G) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
- (H) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
- 8. The prohibitions imposed by Article 4 and 5 shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.
