# (REVOCATION) (NO ENTRY) (ONE WAY) (PROHIBITION OF LEFT/RIGHT TURNS) (PROHIBITION OF WAITING, LOADING OR UNLOADING AT ANY TIME)

#### **ORDER 2018**

The Neath Port Talbot County Borough Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

- 1. This Order shall come into operation on the 16<sup>th</sup> day of July 2018 and may be cited as the "Neath Port Talbot County Borough Council (Ysgol Gymraeg Bro Dur, St Heliers Drive and Western Avenue, Sandfields, Port Talbot) (Revocation) (No Entry) (One Way) (Prohibition of Left/Right Turns) (Prohibition of Waiting, Loading or Unloading at Any Time) Order 2018".
- 2. (1) In this Order
  - "Mechanical Cleansing Vehicle" shall mean a street/drain cleaning vehicle owned by or contracted to the Neath Port Talbot County Borough Council.
  - "Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;
  - "Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.
  - (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
  - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
- 3. The provisions contained in The West Glamorgan County Council (Sandfields, Port Talbot) (Traffic Management) Order 1991 are hereby revoked only in so far as they relate to the sides of lengths of roads as set out in Schedule 1 of this Order.
- 4. The provisions contained in Neath Port Talbot County Borough Council (Various Schools in Neath Port Talbot) (Traffic Management) Order 2005 are hereby revoked only in so far as they relate to the sides of lengths of roads as set out in Schedule 1 of this Order.

- 5. No person shall cause or permit any vehicle to enter those roads specified in Schedule 2 of this Order at the points set out in this Schedule.
- 6. Save as provided in Article 7 of this Order no person shall cause or permit any vehicle to proceed along the lengths of roads set out on Schedule 3 of this Order other than in the direction specified therein.
- 7. Nothing in Article 6 of this Order shall apply to a Mechanical Cleansing Vehicle whilst engaged in any street/drain cleaning operations on behalf of the Neath Port Talbot County Borough Council.
- 8. No person shall cause or permit any vehicle to make a left turn manoeuvre from Ysgol Gymraeg Bro Dur Entrance Road onto St Heliers Drive as set out in Schedule 4 to this Order.
- 9. No person shall cause or permit any vehicle to make a right turn manoeuvre onto Ysgol Gymraeg Bro Dur Entrance Road from St Heliers Drive as set out in Schedule 5 to this Order
- 10. Save as provided in Articles 11 and 12 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload at any time on the lengths of sides of roads set out in the Schedule 6 of this Order.
- 11. Nothing in Article 10 shall render it unlawful to cause or permit any vehicle to wait on the lengths of roads specified therein for so long as may be necessary to enable: -
  - (A) A person to board or alight from a vehicle;
  - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
    - (i) Building, industrial or demolition operations;
    - (ii) The removal of any obstruction to traffic:
    - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
  - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
  - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
  - (E) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;

- (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
- 12. The prohibitions imposed by Article 10 shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

#### **SCHEDULES**

#### **Schedule 1 - Revocation**

#### 1.1 St Helier Drive

From its junction with Access Road to Sandfields Comprehensive School in a north westerly direction to its junction with the roundabout with Western Avenue/Seaway Parade.

1.2 Traethmelyn School – Southdown View, Sandfields

North Side

Between points approximately 76 metres and 144 metres east of its junction with St Helier Drive

#### Schedule 2 – No Entry

#### 2.1 St Helier Drive

No entry to St Helier Drive at a point approximately 18 metres in a south easterly direction from its junction with Seaway Parade Roundabout.

# 2.2 Ysgol Gymraeg Bro Dur (Seaway Parade Exit)

No entry to Ysgol Gymraeg Bro Dur from Seaway Parade at a point approximately 55 metres in a north easterly direction from its junction with Seaway Parade Roundabout.

# 2.3 Ysgol Gymraeg Bro Dur (Seaway Parade Entrance)

No entry to Seaway Parade from Ysgol Gymraeg Bro Dur at a point approximately 175 metres in a north easterly direction from its junction with Seaway Parade Roundabout.

#### Schedule 3 - One Way

#### 3.1 St Helier Drive

One way traffic only in a north westerly direction from a point approximately 20 metres in a south easterly direction from its junction with Seaway Parade Roundabout for a distance of approximately 38 metres in a north westerly direction.

#### 3.2 Ysgol Gymraeg Bro Dur (Seaway Parade Entrance)

One way traffic only in a south easterly direction at a point approximately 175 metres in a north easterly direction from its junction with Seaway Parade Roundabout.

### Schedule 4 - Prohibition of Left Turn

# 4.1 Ysgol Gymraeg Bro Dur Entrance Road

No left turn onto St Helier Drive

#### Schedule 5 - Prohibition of Right Turn

#### 5.1 St Helier Drive

No right turn onto Ysgol Gymraeg Bro Dur Entrance Road.

## Schedule 6 - Prohibition of Waiting, Loading and Unloading at any Time

#### 6.1 St Helier Drive (North East Side)

From its junction with Ysgol Gymraeg Bro Dur Entrance Road for a distance of approximately 20 metres in a north westerly then north easterly direction.

# 6.2 St Helier Drive (North East Side)

From its junction with Ysgol Gymraeg Bro Dur Entrance Road for a distance of approximately 22 metres in a south westerly then south easterly direction.

#### 6.3 St Helier Drive (South West Side)

From its junction with Western Avenue for a distance of approximately 36 metres in a south easterly direction.

#### 6.4 Western Avenue (South East Side)

From its junction with St Helier Drive for a distance of approximately 16 metres in a north easterly direction.

# 6.5 Ysgol Gymraeg Bro Dur Entrance Road (North West Side)

From its junction with St Helier Drive from a distance of approximately 50 metres in a generally north easterly direction.

#### 6.6 Ysgol Gymraeg Bro Dur Entrance Road (South East Side)

From its junction with St Helier Drive for a distance of approximately 40 metres in a north easterly direction.
