**(B4290 LLANDARCY TO SKEWEN)**  
**(NO WAITING AT ANY TIME) (PROHIBITION OF WAITING, LOADING**  
**AND UNLOADING AT ANY TIME)**

**ORDER 2018**

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order shall come into force on the 12<sup>th</sup> day of March 2018 and may be cited as the “Neath Port Talbot County Borough Council (B4290 Llandarcy to Skewen) (Prohibition of Waiting at any time) (Prohibition of Waiting Loading and Unloading At Any Time) and (Traffic Calming) Order 2018”.
  
2. (1) In this Order –
  - “Disabled Person’s Vehicle” has the same meaning as in The Local Authorities’ Traffic Orders (Exemptions for Disabled Persons) (Wales) (Amended) Regulations 2000;
  - “Disabled Persons Badge” has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;
  - “Parking Disc” means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;
  - “Relevant Position” has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;
  - “Public Services Vehicle” shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and “local service” shall have the same meaning as in Section 1 of the Transport Act 1985;
  - “Universal Service Providers” means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.
  
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
  
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

3. Save as provided in Articles 5, 6, 7 and 8 of this Order no person except on the direction of a Police Constable in uniform or of a Parking Attendant shall cause or permit any vehicle to wait at any time on the lengths of sides of road as set out in the Schedule 1 of this Order.
4. Save as provided in Articles 6 and 8 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload at any time on the lengths of sides of roads set out in Schedule 2 of this Order.
5. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a Disabled Person's Vehicle which displays in the relevant position a Disabled Person's Badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the lengths of sides of roads referred to in the Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same length of side of road on which that vehicle had previously been waiting).
6. Nothing in Article 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable: -
  - (A) A person to board or alight from a vehicle;
  - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
    - (i) Building, industrial or demolition operations;
    - (ii) The removal of any obstruction to traffic;
    - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
  - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
  - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
  - (E) Public Services Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
  - (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
7. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable goods to be loaded and unloaded from the vehicle.

8. The prohibitions imposed by Article 3 and 4 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

## SCHEDULES

### Schedule 1 - Prohibition of Waiting At Any Time

- 1.1 Pen Yr Heol, Llandarcy (West Side)**  
From a point approximately 8 metres north of the northern kerbline of Access Road 1 for a distance of approximately 18 metres in a northerly direction.
- 1.2 Pen Yr Heol, Skewen (West Side)**  
From its junction with Cefn Parc for a distance of approximately 13 metres in a southerly direction.
- 1.3 Pen Yr Heol, Skewen (West Side)**  
From its junction with Cefn Parc to its junction with Pen Yr Alley Avenue a distance of approximately 15 metres
- 1.4 Cefn Parc, Skewen (South Side)**  
From its junction with Pen Yr Heol for a distance of approximately 18 metres in a westerly direction.
- 1.5 Cefn Parc, Skewen (North Side)**  
From its junction with Pen Yr Heol for a distance of approximately 21 metres in a westerly direction.
- 1.6 Pen Yr Alley Avenue, Skewen (South West Side)**  
From its junction with Pen Yr Heol for a distance of approximately 22 metres in a north westerly direction.
- 1.7 Pen Yr Alley, Skewen (North East Side)**  
From its junction with Burrows Road for a distance of approximately 18 metres in a north westerly direction.
- 1.8 Burrows Road, Skewen (West Side)**  
From its junction with Pen Yr Alley for a distance of approximately 12 metres in a northerly direction.
- 1.9 Old Road, Skewen (North West Side)**  
From a point approximately 16 metres south of its junction with New Road for a distance of approximately 90 metres in a southerly then south westerly direction.
- 1.10 Old Road, Skewen (South East Side)**  
From a point approximately 16 metre south of its junction with New Road for a distance of approximately 101 metres in a south then south westerly direction.

- 1.11 Old Road, Skewen (North Side)**  
From a point approximately 143 metres north east of the eastern kerbline of Terminus Hill for a distance of approximately 10 metres in an easterly direction.
- 1.12 Old Road, Skewen (North Side)**  
From a point approximately 165 metres north east of the eastern kerbline of Terminus Hill for a distance of approximately 10 metres in an easterly direction.
- 1.13 Old Road, Skewen (South Side)**  
From a distance of approximately 14 metres south west of its junction with Compton Road for a distance of approximately 14 metres in a south westerly direction.
- 1.14 Burrows Road, Skewen (North West Side)**  
From a point approximately 146 metres south west of its junction with Queen's Road for a distance of approximately 26 metres in a south westerly direction.

**Schedule 2 - Prohibition of Waiting, Loading and Unloading at Any Time**

- 2.1 Burrows Road, Skewen (North West Side)**  
From a point approximately 106 metres in a north easterly direction opposite the eastern kerbline of Parc Onen for a distance of approximately 26 metres in a north easterly direction.
- 2.2 Burrows Road, (South East Side)**  
From a point approximately 88 metres north east of the eastern kerbline of Parc Onen for a distance 44 metres in a north easterly direction.
- 2.3 Old Road, Skewen (South East Side)**  
From its junction with Access Road 2 for a distance of approximately 15 metres in a north easterly direction.
- 2.4 Old Road, Skewen (South East Side)**  
From its junction with Access Road 2 for a distance of approximately 15 metres in a south westerly direction.
