(PROHIBITION OF WAITING AT ANY TIME)

ORDER 2017

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order shall come into operation on the 25th day of September 2017 and may be cited as the "Neath Port Talbot County Borough Council (B4434 Tonna Uchaf, Tonna, Neath) (Prohibition of Waiting At Any Time) Order 2017".
2. (1) In this Order –
 - "Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) (Amended) Regulations 2000;
 - "Disabled Persons Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;
 - "Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;
 - "Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;
 - "Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;
 - "Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

7. The prohibitions imposed by Article 3 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

SCHEDULE

Schedule 1 – Prohibition of Waiting At Any Time

B4434 Tonna Uchaf, Tonna, Neath – North Side

From a point approximately 69 metres east of its junction with Pen y Bryn for a distance of approximately 18 metre in an easterly direction into the left hand side of the Tonna Hospital West Entrance.

From a point approximately 88 metres east of its junction with Pen y Bryn (on the right hand side of the Tonna Hospital West Entrance) for a distance of approximately 27 metres in an easterly direction.

From a point approximately 146 metres east of its junction with Pen y Bryn for a distance of approximately 8 metres in an easterly direction into the left hand side of the Tonna Hospital East Entrance.

From a point approximately 156 metres east of its junction with Pen y Bryn (on the right hand side of the Tonna Hospital East Entrance) for a distance of approximately 23 metres in an easterly direction.
