## (NO WAITING, LOADING OR UNLOADING AT ANYTIME) AND (LOADING BAY)

### **ORDER 2004**

#### THE NEATH PORT TALBOT COUNTY BOROUGH COUNCIL in

exercise of its powers under Sections 1, 2, 32 and 35 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

 This Order shall come into operation on the 9<sup>th</sup> day of January 2004 and may be cited as the "Neath Port Talbot County Borough Council (Hoo Street and Short Street Briton Ferry) (No Waiting, Loading or Unloading at Anytime) and (Loading Bay) Order 2004.

2. (1) In this Order -

"Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;

"Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

"Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;

"Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

"Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;

"Universal Service Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.

"Loading Bay" means a parking place designated by this Order as a parking place only for the use of vehicles which are being loaded or unloaded.

- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

3. Save as provided in Articles 5 and 6 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload at any time on the lengths of sides of roads set out in Schedule 1 of this Order.

- (1) The Loading Bay as set out in Schedule 2 of this Order is designated as a parking place between the hours of 8.00am and 6.00pm on any day except Sunday for vehicles which are being loaded or unloaded only subject to the proviso that any such vehicle using the Loading Bay for the purpose of loading or unloading shall not remain in the Loading Bay for more than 30 minutes duration at any given time.
- (2) Save as provided by Articles 5 and 6 of this Order no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle (including a Disabled Persons Vehicle) to use the Loading Bay referred to in Article 4 (1) above other than for the purpose of loading or unloading vehicles subject to the proviso specified in that Article.
- 5. Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable: -

(A) A person to board or alight from a vehicle;

(B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely: -

- (i) Building, industrial or demolition operations;
- (ii) The removal of any obstruction to traffic;
- (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
- (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
- (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
- (E) Public Services Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
- (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
- 6. The prohibitions imposed by Articles 3 and 4 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

### **SCHEDULES**

#### Schedule 1 - No Waiting, Loading Or Unloading at Anytime

iii) <u>Cwrt Sart – West Side</u>

From its junction with Short Street for a distance of approximately 8 metres in a Northerly direction and 5 metres in a Southerly direction

## iv) <u>Short Street – Both Sides</u>

From its junction with Cwrt Sart for a distance of approximately 6 metres in a Westerly direction.

# <u>Schedule 2 – Loading Only, Maximum Duration 30 Minutes, Monday</u> to Saturday 6am-Noon

## Hoo Street - South Side

Between points approximately 8 metres and 24 metres west of its junction with Neath Road.
