THE NEATH PORT TALBOT COUNTY BOROUGH COUNCIL (OFF-STREET PARKING PLACES) (THIRD AMENDMENT) ORDER 1999

The Neath Port Talbot County Borough Council in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 of the Act hereby make the following Amendment Order.

- 1. This Order shall be cited as The Neath Port Talbot County Borough Council (Off-Street Parking Places) (Third Amendment) Order 1999.
- 2. This Order shall come into operation on the 20th day of December 1999 and shall have the following effect:
- 2.1. As regards the Parking Places situated within the environs of the Port Talbot Town Centre:
 - 2.1.1. to change the commencement of the hours of operation from 9.00 a.m. to 8.00 a.m., and
 - 2.1.2. to increase the maximum period for which a vehicle may wait from 9 hours to 10 hours
- 2.2. As regards the Parking Places situated within the environs of the Neath Town Centre (with the exception of Milland Road Car Park):
 - 2.2.1. to reduce the maximum period for which a vehicle may wait from 10 hours to 4 hours, and
 - 2.2.2. to reduce the duration of the Scale of Charges to reflect the amendment in 2.1 above
- 3. As regards all Parking Places within the environs of both the Port Talbot and Neath Town Centres (with the exception of Milland Road Car Park):
- 3.1. to increase the Scale of Charges
- 4. As regards all Parking Places within the environs of the Port Talbot and Neath Town Centres (with the exception of the Civic Centre Car Parks in Port Talbot and Neath, and Milland Road Car Park):
- 4.1. to increase the cost of the season tickets and as set out in the Amended Schedule 3 hereto
- The Neath Port Talbot County Borough Council (Off-Street Parking Places) (Second Amendment) Order 1999 therefore shall be amended in that as to Amended Schedule 1 attached thereto there shall be substituted the Amended Schedule 3 attached to this Amendment Order.
