WEST GLAMORGAN COUNTY COUNCIL

(OSBORNE STREET AND REES PLACE)

(PROHIBITION OF WAITING, LOADING AND UNLOADING)

ORDER 1985

The West Glamorgan County Council (hereinafter referred to as the County Council) in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other powers hem enabling and after consultation with the Chief Officer of Police in accordance with Section 124 of the Act of 1984, hereby make the following Order:-

- 1. This Order shall come into operation on 26H August 1985 and may be cited as the West Glamorgan County Council (Osborne Street and Rees Place) (Prohibition of Waiting, Loading and Unloading) Order 1985.
- 2. (1) In this Order -

"disabled person's badge" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975;

"parking disc" means a disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (BS. No.4631: 1970) but coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.

- (2) For the purpose of this Order a vehicle shall be regarded as displaying -
 - (a) a disabled person's badge in the relevant position when -
 - (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen, and
 - (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or nearside of the vehicle, and
 - (b) a parking disc in the relevant position, when the disc is exhibited thereon with the side which shows the time facing forwards or outwards and immediately behind the windscreen or side windows nearest to the kerb.

- (3) Except where otherwise stated any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing the number in this Order.
- (4) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Save as provided in Article 5 of this Order no person shall, except upon the direction of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait, be loaded or unloaded at any time on the length of road specified in Schedule 1 to this Order.
- 4. Save as provided in Articles 5 and 6 of this Order no person shall cause or permit any vehicle to wait between the hours of 8.00 a.m. and 6.00 p.m. on any day Except Sunday on the side or length of road specified in Schedule 2 to this Order.
- 5. Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the length or lengths of road specified therein for so long as may be necessary to enable:-
 - (i) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (a) building, industrial or demolition operations;
 - (b) the removal of any obstruction to traffic;
 - (c) the maintenance, improvement or reconstruction of the side of road; or
 - (d) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878; or
 - the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - (iii) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
 - (iv) the vehicle to be used for police, fire brigade or ambulance purposes;
 - (v) a public service vehicle to load or off load passengers at a duly authorised bus stop marked by a bus stop markings and signs in accordance with the Traffic Signs Regulations and General Directions 1981 or any succeeding Regulations.

- 6. Nothing in Article 4 of this Order shall render it unlawful to:-
 - (i) cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling persons to board or alight from the vehicle or goods to be loaded or unloaded from the vehicle and
 - (ii) cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in that Article for a period not exceeding two hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length or on the same side of road on the same day).
- 7. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE ONE

PROHIBITION OF WAITING, LOADING AND UNLOADING AT ANY TIME

Osborne Street (South Side)

From the eastern kerb line of Rees Place for a distance of 5 metres in an easterly direction.

From the western kerb line of Rees Place for a distance of 5 metres in a westerly direction.

Rees Place (Both Sides)

From the southern kerb line of Osborne Street for a distance of 24 metres approximately in a southerly direction (to the northern side of the access lane).

SCHEDULE TWO

'No Waiting - 8.00 a.m. to 6.00 p.m. Monday to Saturday'

Rees Place (East Side)

From a point 24 metres approximately south of the southern kerb line of Osborne Street for a distance of 23 metres approximately in a southerly direction.
